G. NECROPSY STUDIES WITH OKLAHOMA ANIMAL DISEASE DIAGNOSTIC LABORATORY (OADDL)

Consideration:

The Commission will consider the Renewal of Veterinary Medical Diagnostic Program & Necropsy Study. The Oklahoma Bred Advisory Council unanimously recommends to the Commission that the Necropsy Study Fund be replenished to return to the budget \$50,000 for FY 2026.

Possible Action:

Possible actions may include but is not limited to: taking no action; approve the replenishment of the Necropsy Study Fund as recommended by the Oklahoma Bred Advisory; approve the replenishment as modified; deny the action; or continue the matter.

H. PRELIMINARY CONSIDERATION OF CY 2026 RACING AND GAMING APPLICATIONS

The Commission received renewal applications from Remington Park and Will Rogers Downs for their respective organization license for gaming operations, live racing and simulcasting for CY 2026 as well as Fair Meadows Tulsa CY 2026 renewal applications for their live racing, simulcasting and gaming recipient licenses.

Historically, the Commission has determined that a full formal Public Hearing would be conducted only on original applications for organization and gaming licenses. On renewal applications, the Public Hearing is limited to a presentation by a racetrack representative followed by a question-and-answer period by Commissioners, Commission Counsel and Commission Staff.

The following is a summary of the race day applications received.

1. REMINGTON PARK

Remington Park [RP] applied to conduct two race meetings:

- A Quarter Horse, Pain and Appaloosa race meeting, 50 days in length, from March 5, 2026 thru May 30, 2026. [422 QH, 78 PT/APP]
- A Thoroughbred race meeting, 60 days in length, from August 7, 2026, thru December 18, 2026. [600 TB races]

Remington Park submitted a Racetrack Gaming Operator License application. Staff Briefs have been completed on Remington Park's CY 2026 racing and gaming license applications.

2. WILL ROGERS DOWNS

Will Rogers Downs [WRD] applied to conduct two race meetings:

- A Quarter Horse, Pain and Appaloosa race meeting, 28 days in length, from September 7, 2026 thru November 10, 2026. [270 QH, PT/APP-TBD]
- A Thoroughbred race meeting, 27 days in length, from January 12, 2026, thru April 27, 2026. [270 TB races]

Will Rogers Downs submitted a Racetrack Gaming Operator License application. Staff Briefs have been completed on Will Rogers Down's CY 2026 racing and gaming license applications.

3. TULSA STATE FAIR (TULSA COUNTY PUBLIC FACILITIES AUTHORITY)

The Tulsa State Fair (the Tulsa County Public Facilities Authority) [FMT] applied to conduct one fair race meeting:

• A Thoroughbred, Quarter Horse, Paint and Appaloosa fair race meeting at Fair Meadows, Tulsa, 27 race days in length, from June 3, 2025, thru July 18, 2026.

Fair Meadows [FMT] submitted a Recipient Racetrack Gaming License application. Staff Briefs have been completed on the Tulsa County Public Facilities Authority's CY 2026 racing and recipient gaming license applications.

THE FOLLOWING PROCEDURES PERTAIN TO THE PRESENTATIONS REGARDING RACING AND GAMING RENEWAL APPLICATIONS FOR ORGANIZATION LICENSES.

Each racetrack will be given up to ten (10) minutes to make its presentation on its CY 2026 racing and gaming renewal license applications with a concentration on changes proposed or made since the CY 2025 applications. Following the presentation, Commissioners, Commission Counsel and Commission Staff may ask questions. The period taken with questions and answers will not be charged against the time allotted to the Applicant.

POSSIBLE ACTION:

Possible action may include: taking no action; taking preliminary action to allot CY 2026 live race dates and directing Commission Staff to draft CY 2026 racing and companion gaming license orders subject to staff reports and consideration of the Staff Briefs and draft orders for consideration in further deliberations at the October 16, 2025 meeting; or continuing consideration to the October 16, 2025 meeting.
