**A. Call to Order**

Chairman Burget called the meeting to order at 9:30 a.m.

**B. Roll Call and Announcement of Quorum**

Commissioners answering roll call were, Commissioner Brookover, Commissioner Carter, Commissioner McNally, Commissioner Greg, Commissioner Fuser, Commissioner Terry, Commissioner Craig, Vice Chairman Murray and Chairman Burget.

**C. Discussion and possible action regarding the minutes of October 16, 2025, regular meeting.**

Chairman Burget announced item C.

Commissioner Craig moved to accept the minutes from October 16, 2025, regular meeting as presented. Commissioner Terry seconded the motion. The vote was as follows:

**D. Executive Staff Reports**

Chairman Burget announced consideration of item D.

Reports were given by division directors on agency progress, strategic priorities and key challenges. Directors give reports were Interim Executive Director Amanda English, Chief Steward Glen Murphy, General Counsel Michael Copeland, Director of Law Enforcement Robert Duvall and Financial Manager Martha Del Rio.

**E. Preliminary consideration of, and possible action regarding, CY2026 racing and gaming applications of Fair Meadows.**

Chairman Burget announced consideration of item E.

General Counsel Michael Copeland announced that Fair Meadows CY 2026 renewal applications for organization racing licenses and recipient gaming licenses have been reviewed and considered and substantially meet the commission requirements for renewal and be approved.

**H. Discussion of reconciliation of wagers that inadvertently occurred without a simulcast contract**

Interim Director Amanda English, Global Gaming Attorney Jared Easterling and Mutuels Manager Carrie Stallbories presented a plan to establish a process of reconciliation.

**I. Possible action on proposed rule amendments to certain chapters in rules of racing under permanent rulemaking.**

Chairman Burget announced consideration of item I.

General Counsel Michael Copeland announced that staff was seeking authorization for the initiation of the rule making process and asked for approval to file the notice of rulemaking intent with the office of administrative rules for publication in the Oklahoma Registrar on December 15, 2025, establish a public comment period in accordance administrative procedures act and set the public hearing for the rule amendments January 15, 2026 at 830 am in the Denver Davis Building conference room 325.

Commissioner Fuser motioned to approve the proposed rule amendments for the purpose of initiating permanent rule making and authorized the staff to file the notice of rulemaking intent with the office of administrative rules and establish the required public comment period and set the public hearing for January 15, 2026, at 8:30 am. Commissioner Brookover seconded the motion. The vote was as follows:

**J. Discussion and possible action regarding the proposed final order in OQHRA and Will Rogers Downs V. Sammy Mendoza Case No. 2024-OHRC-015 concerning a substance violation as a condition of entry.**

Chairman Burget announced consideration of item J.

General Counsel Michael Copeland was present for the Oklahoma Horse Racing Commission. Krissy Bamberg was present for OQHRA. The appellant, Samuel Mendoza was not present. Mr. Copeland announced that this matter had already been discussed, voted on and approved with a modification to send back to the Administrative Law Judge for clarification that the order was for a declaratory judgement.

Commissioner McNally motioned to approve the final order subject to one modification and authorize the General Counsel to make the modification and authorize the Chairman to sign the order outside of the meeting. Commissioner Terry seconded the motion.

**K. Discussion and possible action regarding the proposed agreed final order in David Guajardo, Case No. 2025-OHRC-05 concerning a substance violation as condition of entry.**
