## **I. POSSIBLE ACTION ON PROPOSED RULE AMENDMENTS TO CERTAIN CHAPTERS IN RULES OF RACING UNDER PERMANENT RULEMAKING**

Staff will present proposed amendments to the following chapters in the Rules of Racing for consideration under the permanent rulemaking process pursuant to the Oklahoma Administrative Procedures Act (75 O.S. § 303):

### **Rules of Racing:**

- Chapter 1, Commission Powers and Jurisdiction
- Chapter 15, Licensing
- Chapter 25, Entries and Declarations
- Chapter 45, Prohibited Practices and Equine Testing
- Chapter 65, Pari-Mutuel Wagering
- Chapter 70, Objections and Protests: Hearing and Appeals
- Chapter 75, Oklahoma Bred Program

### **Consideration:**

The Commission will consider the proposed rule amendments and the associated Rule Impact Statement. If approved, the Commission will authorize staff to file the Notice of Rulemaking Intent with the Office of Administrative Rules for publication in the Oklahoma Register, provide copies to the Governor, the appropriate Cabinet Secretary, and the Governor's Office of General Counsel as required by law, establish a public comment period of at least thirty (30) days, and set the date, time, place, and manner for a public hearing on the proposed amendments.

### **Possible Action:**

Possible action may include, but is not limited to: taking no action; approving the proposed rule amendments and Rule Impact Statement; authorizing staff to file and publish the Notice of Rulemaking Intent; setting the public comment period; scheduling a public hearing (including date, time, place, and format); modifying the proposed amendments prior to proceeding; continuing the matter; or any other actions necessary to initiate the permanent rulemaking process.

## **J. Discussion and possible action regarding the proposed final order in OQHRA and Will Rogers Downs V. Sammy Mendonza Case No. 2024-OHRC-015 concerning a substance violation as condition of entry.**

### **Consideration:**

The Commission will consider whether to approve the proposed amended final order. The matter was assigned by the Commission to the Hearing Officer. The matter was adjudicated by Petitioners' Joint Motion for Summary Disposition. Pursuant to 325:70-1-25, the Hearing Officer, has drafted a proposed an amended final order for the Commission to consider that finds in favor of Petitioners and disqualifies the Respondent's horse and denies participation in the purse of other awards. Pursuant to 25 O.S. § 307 (B)(1), and Executive Session may be proposed

for the purpose of deliberations regarding an individual proceeding and the proposed final order. Possible action may include but not limited to: discussion; taking no action; approving final order as proposed; approving the final order as modified; denying the final order and continuing the matter

1. Motion and Vote to go into Executive Session for the purposes stated above.
2. Vote to exit Executive Session.
3. Discussion and possible action may include but not limited to: discussion; taking no action; approving the final order as proposed; approving the final order as modified; denying the final order and continuing the matter, consistent with 25 O.S. § 307(B)(1).

**K. Discussion and possible action regarding the proposed agreed final order in David Guajardo, Case No. 2025-OHRC-12 concerning a substance violation as condition of entry.**

**Consideration:**

The Commission will consider whether to approve the proposed agreed final order. The matter was assigned by the Commission to the Hearing Officer and set for hearing. However, the parties have reached a consent agreement, and pursuant to 325:70-1-25, a proposed agreed final order has been drafted for the Commission to consider that finds in favor of Petitioners and disqualifies the Respondent's horse and denies participation in the purse or other awards. Pursuant to 25 O.S. § 307(B)(8), an Executive Session may be proposed for the purpose of deliberating regarding the individual proceeding and the proposed agreed final order. Possible action may include, but not limited to: discussion; taking no action; approving the agreed final order as proposed; approving the agreed final order as modified; denying the agreed final order and continuing the matter.

1. Motion and Vote to go into Executive Session for the purposes stated above.
2. Vote to exit Executive Session.
3. Discussion and possible action may include but not limited to: discussion; taking no action; approving the final order as proposed; approving the final order as modified; denying the final order and continuing the matter, consistent with 25 O.S. § 307(B)(8).

**L. Discussion and possible action regarding implementation of hair testing pursuant to Oklahoma Rules of Racing.**

The Commission will consider guidance to the Executive Director on implementation of hair testing, pursuant to OAC 325.45.
