Substitute Trainer Juvenal Licon-Vazquez saddled #7 "CEREZA LAGO" for Trainer Rodrigo Covarrubias


RACE #2 #7 "DESTINY OF THE NILE BC" was very green, ducked in and out

#5 "SUNNYSIDE DYNASTY" stumbled at the start


RACE #4 **HERITAGE PLACE DERBY TRIAL #2**
