At the time of this signing, the horse is alive and the death of this horse shall be reported to the Commission within 30 days of such occurrence. I further understand that this application and any information submitted with this application is subject to disclosure under the Open Records Act of Oklahoma and that, except where specific State or Federal statute creates a confidential privilege, persons who submit information to public bodies have no right to keep such information from public access nor reasonable expectation that such information will be kept from public access. Lastly, I understand that this application will be rejected with no refund of fees for failure to complete the registration process by the applicant not providing all required documents and/or information within one (1) year from the date the application is submitted to the Oklahoma Horse Racing Commission.
