Mr. Ferguson called the meeting to order at 2:03 p.m. Roll was called and a quorum was established.

Dr. Stewart motioned to adopt the minutes from the March 14, 2013 meeting. Mr. McElvany seconded the motion. Roll was called, Dr. Sloka abstained, and all others were in favor.

Mrs. Elliott provided an Agency update.

●Financial snapshot: With our monthly appropriations of \$599K and April deposits of \$203K we had a \$158.9K carryover this past month.

●Mrs. Elliott advised that Dr. Eric Duval rejoined the Agency effective April 30, 2013. Ms. Tulani Page, Megan Harris and Josh Irvin were all hired as investigators in the Tulsa office. A full time security officer Josh Terrill has been hired for the Tulsa office. Dr. Patterson starts with the Agency in Oklahoma City on October 1<sup>st</sup>. Dr. Stolzenberg begins his fellowship in Oklahoma City approximately July 15<sup>th</sup>.

●Senate Bill 37 was signed into law on April 24<sup>th</sup> and goes into effect on November 1<sup>st</sup>. This will take the State Department of Health out of the approval process when issuing a transport out of state permit.
