## What to expect from a screening or assessment.

- You will call to set up an appointment for a screening.
- You will be given a time to be at a location and told what to bring with you.
- You may be asked questions about your child's development.
- You and your child will be given opportunities to answer questions and/or use materials and activities.
- You will be given a summary at the time of the assessment or at a follow-up appointment.
- You will decide which suggestions will be best for your child and your family.

Other resources that may provide screenings and assessments are your local pediatrician, community services or public school systems.
