Preventive Services	How Often Allowed	For Medical Providers Who Accept Assignment
Welcome to Medicare Preventive Visit	Within First 12 months on Medicare Part B	Covered at 100%
Yearly "Wellness" Visits	Once Every 12 Months	Covered at 100%
Cardiovascular Disease Screenings	Screening Blood Tests Once Every 5 Years	Covered at 100%
Cardiovascular Behavioral Therapy	One Time Each Year with Your Primary Care Doctor	Covered at 100%
Abdominal Aortic Aneurysm Screenings	Covers an Abdominal Aortic Screening Ultrasound Once if You're at Risk	Covered at 100%
Lung Cancer Screening	Must Meet 5 Conditions	Covered at 100%
Diabetes screenings	You May be Eligible for up to 2 Screenings Each Year if You have Specific Risk Factors	Covered at 100%
Diabetes Self-Management Training	10 Hours of Initial DSMT Training and up to 2 Hours of Follow-up Training each Year	You pay 20%
Multi-Target Stool DNA Tests	Once Every 3 Years if You Meet Certain Conditions	Covered at 100%
Screening Fecal Occult Blood Tests	Once Every 12 Months if You're 50 or Older and You get a Referral from Your Primary Caregiver	Covered at 100%
Screening Flexible Sigmoidoscopies	48 months or 120 months after previous screening if not high risk and 50+	Covered at 100%
Screening Barium Enemas	Coverage Varies with Your Risk Factors	You pay 20%
Screening Colonoscopies	Once Every 24 Months if You're at High Risk for Colorectal Cancer, or Once Every 120 Months if You are not at High Risk	Covered at 100%
Bone Mass Measurements (Bone Density Tests)	Once Every 24 Months if You Meet One of 5 Conditions	Covered at 100%
Cervical & Vaginal Cancer Screenings	Medicare Covers These Screening Tests Once Every 24 Months or more often if You are at High Risk	Covered at 100%
Mammograms	One Baseline if You're a Woman Between Ages 35-39. Once Every 12 months if You're a Woman Age 40 or Older. Diagnostic Mammograms More Frequently if Medically Necessary.	Covered at 100%
Prostate Cancer Screenings	Digital Rectal Exams and Prostate Specific Antigen (PSA) Blood Tests Once Every 12 Months for Men Over 50	You pay 20%
Glaucoma Tests	Once Every 12 Months if You're at High Risk	You pay 20% and Deductible Applies

Nutrition Therapy Services	If You Have Diabetes or Kidney Disease, or You've had a Kidney Transplant in the last 36 Months	Covered at 100%
Obesity Screenings & Counseling	If You Have a Body Mass Index (BMI) of 30 or More	Covered at 100%
Depression Screenings	One Depression Screening per Year	Covered at 100%
Coronavirus Disease 2019 (COVID 19) Vaccine	You Won't Pay a Deductible or Co-payment	Covered at 100%
Flu Shots	One flu shot per flu season	Covered at 100%
Pneumococcal Shots	Covers the First Shot at any Time and a Different, Second Shot if it's Given at Least One Year After the First Shot	Covered at 100%
Hepatitis B Shots	If You're at Medium or High Risk for Hepatitis B	You pay 20% of the Medicare-Approved amount after meeting the Part B deductible
Counseling to Prevent Tobacco Use & Tobacco Caused Disease	Covers 8 Visits of Smoking and Tobacco-Use Cessation Counseling Visits in a 12-Month Period	Covered at 100%
Alcohol Misuse Screenings & Counseling	Covers an Alcohol Misuse Screening Once per Year if You're an Adult (Including Pregnant Women) Who Uses Alcohol, but You don't meet the Medical Criteria for Alcohol Dependency	Covered at 100%
Hepatitis B Virus Infection Screenings	If Your Primary Care Provider Orders it and You're at High Risk or Pregnant	Covered at 100%
Sexually Transmitted Infection Screenings & Counseling	Covers Sexually Transmitted Infection (STI) Screenings for Chlamydia, Gonorrhea, Syphilis, and/or Hepatitis B if You're Pregnant or at Increased Risk for an STI. Medicare Also Covers up to 2 Individual 20-30 Minute, Face-to-Face, High-Intensity Behavioral Counseling Sessions if You're a Sexually Active Adolescent or Adult at Increased Risk for STIs.	Covered at 100%
Hepatitis C Screening Tests	Medicare Covers One Screening Test if You Meet the Conditions Including if You were Born Between 1945-1965	Covered at 100%
HIV Screenings	Screening Once per Year if You Meet Certain Conditions	Covered at 100%
Shingles Vaccine	Generally covered under Medicare Part D	Contact your Medicare drug plan for information about coverage
