CONSENT ORDER

The Petitioner, State of Oklahoma, ex rel., Department of Consumer Credit ("Petitioner") and the Respondent, Le'Shawd Driver, ("Respondent") voluntarily enter into this Consent Order as an informal disposition of this individual proceeding to avoid litigation. The Respondent agrees to waive its right to a hearing under the Oklahoma Administrative Procedures Act and both parties agree as follows:

(1) The Petitioner restates and incorporates by reference the allegations made by the Petitioner in the Notice of Hearing filed in this matter.

- a. The Petitioner received notice from the Oklahoma Tax Commission that Le'Shawd Driver PME07492, was not compliant with the income tax laws of the State of Oklahoma on July 11, 2012.
- b. The Respondent requested a renewal of her precious metal employee license on November 27, 2012.
- c. As of April 5, 2013, the Petitioner has not received notification from the Oklahoma Tax Commission stating that the Respondent is in compliance with the income tax laws of the State of Oklahoma.

(2) The Respondent does not admit to the allegations made by the Petitioner in the Notice of Hearing filed in this matter and incorporated by reference in this Consent Order.

(3) The Respondent agrees to withdraw his license renewal application for precious metal employee license, PME07492 on or before June 17, 2013.

(4) A file stamped copy of this Consent Order will be returned by United States mail to the Respondent upon signature of the Administrator of the Department of Consumer Credit or the Deputy Administrator of the Department Consumer Credit.

(5) If the Respondent fails to comply with the terms of this Consent Order, the Administrator of the Department of Consumer Credit is authorized to file an application to enforce this Consent Order in the District Court of Oklahoma County, Oklahoma in accordance with the provisions of 59 O.S. § 1528(G) of the Precious Metal and Gem Dealer Licensing Act.
