 - ii. The Respondent is a licensed precious metal and gem dealer; license number PM007479, transacting business at 4901 N. Kickapoo, Suite 154, Shawnee, OK 74804.
 - iii. On December 2, 2013, a Department Examiner went to the Respondent's business location at 4901 N. Kickapoo, Suite 154, Shawnee, OK 74804, to conduct an inspection of the Respondent's precious metal and transactions. gem location is the Mall; the Department Shawnee Examiner unable locate Respondent's was to business. Department Examiner called Respondent who stated he had closed his business in May 2013.

- iv. The Respondent failed to notify the Department that they were moving the records to a new location.
- v. The Respondent has failed to notify the Department that they were closing the business location and surrendering their license.
- (2) The Respondent does not admit to the allegations made by the Petitioner in the Notice of Hearing(s) filed in this matter and incorporated by reference in this Consent Order.
- (3) The Respondent agrees to pay \$250.00 in civil penalties on or before May 1, 2014.
- (4) The Respondent agrees to provide written documentation that the business has been dissolved and Respondent has requested to surrender the precious metal and gem dealer license number PM007479.
- (5) The payment shall be made payable by check or money order to the Oklahoma Department of Consumer Credit, shall indicate the payment is for Case Number 14-0038-DIS and shall be addressed to the attention of Roy John Martin, General Counsel, Department of Consumer Credit, 3613 N.W. 56th Street, Suite 240, Oklahoma City, Oklahoma 73112.
- (6) A file stamped copy of this Consent Order will be returned by United States mail to the Respondent upon signature of the Administrator of the Department of Consumer Credit or the Deputy Administrator of the Department Consumer Credit.
- (7) If the Respondent fails to comply with the terms of this Consent Order, the Administrator of the Department of Consumer Credit is authorized to file an application to enforce this Consent Order in the District Court of Oklahoma County, Oklahoma in accordance with the provisions of 14A O.S. § 6-113
