## CONSENT ORDER

The Petitioner, State of Oklahoma, ex rel., Department of Consumer Credit ("Petitioner") and the Respondent, Crossfit Native, LLC, enter into this Consent Order as an informal disposition of this individual proceeding to avoid litigation. The Respondent agrees to waive its right to a hearing under the Oklahoma Administrative Procedures Act and both parties agree as follows:

- (1) The Petitioner restates and incorporates by reference the allegations made by the Petitioner in the Notice of Hearing filed in this matter:
  - i. The Respondent is a domestic limited liability company, with an inactive filing status with the Oklahoma Secretary of State, filing number 3512258321, transacting business at 8037 Northwest Expressway, Oklahoma City, Oklahoma 73162.
  - ii. The Respondent was previously registered as a health spa in the State of Oklahoma at 6103 NW 58th Street, Warr Acres, Oklahoma 73122, registration number SPA00547.
  - iii. A delinquency notice dated January 15, 2014 was submitted by the Petitioner to the Respondent indicating that the Respondent's license renewal application was not submitted with all fees and postmarked on or before December 1, 2013. The delinquency notice further stated that the Respondent's license would expire fifteen (15)

- days from the date of the delinquency notice unless the Respondent submitted a renewal application and all fees, postmarked on or before February 3, 2014.
- On January 23, 2014, Kirk A. Suiter, the owner iv. the Respondent, submitted an electronic mail notification to the Petitioner confirming receipt of the delinquency notice submitted by the Petitioner on January 14, 2014. Mr. Suiter further stated that as a result to an amendment made to the Oklahoma Health Spa Act at 59 O.S. 2001(5)(h) by House Bill 1639, the Oklahoma Health Spa Act no longer applied to the Respondent since the term health spa does not include any facility that only offers monthto-month memberships and does not charge application, process, cancellation, or other services fees. Mr. Suiter further stated that in accordance with House Bill 1639, he would not be renewing the health spa license of the Respondent.
