CONSENT ORDER

The Petitioner, State of Oklahoma, ex rel., Department of Consumer Credit ("Petitioner") and the Respondent, Horizon Motors North, LLC, ("Respondent") voluntarily enter into this Consent Order as an informal disposition of this individual proceeding to avoid litigation. The Respondent agrees to waive its right to a hearing under the Oklahoma Administrative Procedures Act and both parties agree as follows:

- (1) The Petitioner restates and incorporates by reference the allegations made by the Petitioner in the Notice of Hearing filed in this matter.
 - i. The Respondent is registered as a domestic limited liability company in the State of Oklahoma, Oklahoma Secretary of State filing number 3512100933, active filing status.
 - ii. The Respondent transacts business at 3425 N. May, Oklahoma City, OK 73112.
 - iii. On August 4, 2016, a consumer credit examiner entered the business premises of the Respondent and spoke to an employee named Raul. Later that day, the examiner met with Sam (the owner) to discuss the potential purchase of a 2006 Monte Carlo.
 - iv. After test driving the vehicle, Sam offered inhouse financing with an \$800 down payment for the

2006 Monte Carlo. Sam told the examiner that he could finance it himself for \$300 a month for 21 months with the \$800 down payment. The purchase price of the vehicle was listed at \$6950.00. The vehicle's windshield had a sign that stated an \$800 down payment.

- v. The business card for Sam of Horizon Motors North, LLC, lists "In-House Financing" directly on the card.
- vi. As of August 15, 2016, the Respondent is not licensed in the State of Oklahoma pursuant to the provisions of 14A O.S. §§ 6-201 through 6-203 of the UCCC. 14A O.S. § 6-203(2).
- vii. The Respondent did not file notification pursuant to the provisions of Section 6-201 of the UCCC, on or before January 31, 2016.
- viii. Respondent has failed to pay the notification filing fee of \$120.00 for each business location pursuant to OKLA. ADMIN. CODE § 160:5-1-2(2)(A).
- (2) The Respondent does not admit to the allegations made by the Petitioner in the Notice of Hearing filed in this matter, and incorporated by reference in this Consent Order.
- (3) The Respondent agrees to pay a civil penalty in the amount of \$2,500.00, payable to the Oklahoma Department of Consumer Credit, on or before September 26, 2016.
- (4) The payment shall be made payable by check or money order to the Oklahoma Department of Consumer Credit, shall indicate the payment is for Case Number 16-0125-DIS and shall be addressed to the attention of Roy John Martin, General Counsel, Department of Consumer Credit, 3613 N.W. 56th Street, Suite 240, Oklahoma City, Oklahoma 73112.
- (5) The Respondent did file notification pursuant to the provisions of Section 6-201 of the UCCC, as to the business location at 3520 N. May, Oklahoma City, OK 73112, on September 6, 2016. Said license was issued to Respondent on September 12, 2016.

(6) A file stamped copy of this Consent Order will be returned to the Respondent upon signature of the Administrator of the Department of Consumer Credit or the Deputy Administrator of the Department Consumer Credit.

(7) If the Respondent fails to comply with the terms of this Consent Order, the Administrator of the Department of Consumer Credit is authorized to file an application to enforce this Consent Order in the District Court of Oklahoma County, Oklahoma in accordance with the provisions of 59 O.S. §

2095.17(c).


