CONSENT ORDER

The Petitioner, State of Oklahoma, ex rel., Department of Consumer Credit ("Petitioner") and the Respondent, Arsha, Inc., d/b/a Import Motors, ("Respondent") voluntarily enter into this Consent Order as an informal disposition of this individual proceeding to avoid litigation. The Respondent agrees to waive its right to a hearing under the Oklahoma Administrative Procedures Act and both parties agree as follows:

- (1) The Petitioner restates and incorporates by reference the allegations made by the Petitioner in the Notice of Hearing filed in this matter.
 - i. The Respondent is registered as a domestic for profit business corporation in the State of Oklahoma, Oklahoma Secretary of State filing number 1900618821, active filing status.
 - ii. The Respondent transacts business at 7207 NW 39th Street, Bethany, OK 73008.
 - iii. On August 30, 2016, a consumer credit examiner entered the business premises of the Respondent and spoke to Mr. Jose Frias. The examiner asked Mr. Frias if the location offered in-house financing. Mr. Frias did advise the examiner that the location does offer in-house financing.
 - iv. Mr. Frias called his manager, Gus Mazroy and the examiner spoke to him on the telephone. Examiner

- requested a copy of a completed contract, a blank contract and a business card. Mr. Mazroy agreed to allow Mr. Frias provide the examiner with a copy of the documents.
- Mr. Frias provided examiner with a copy of a current Retail Installment Contract, Agreement and Disclosure statement listing the purchase of a 2003 Ford F-150 truck. The terms of the contract are forty (40) monthly payments amount ο£ \$150.00 with an percentage rate of 21%. First payment scheduled on August 31, 2016.
- vi. The Respondent maintains an Internet website at http://www.importmotorsok.com/. On the website, there is an online application available.
- vii. As of August 30, 2016, the Respondent was not licensed in the State of Oklahoma pursuant to the provisions of 14A O.S. §§ 6-201 through 6-203 of the UCCC. 14A O.S. § 6-203(2).
 - The Respondent is licensed as of September 8, 2016. The Department received Respondent's notification filing application on September 1, 2016. Respondent was issued a notification filing permit on September 8, 2016.
- viii. The Respondent did not file notification pursuant to the provisions of Section 6-201 of the UCCC, on or before January 31, 2016.
- (2) The Respondent does not admit to the allegations made by the Petitioner in the Notice of Hearing filed in this matter, and incorporated by reference in this Consent Order.
- (3) The Respondent agrees to pay all applicable registration/application fees and a \$1,000.00 civil penalty, payable to the Oklahoma Department of Consumer Credit, on or before October 31, 2016.
- (4) The payment shall be made payable by check or money order to the Oklahoma Department of Consumer Credit, shall indicate the payment is for Case Number 16--0158--DIS and shall be addressed to the attention of Roy John Martin, General Counsel, Department of Consumer Credit, 3613 N.W. 56^{th} Street, Suite 240,
