CONSENT ORDER

The Petitioner, State of Oklahoma, ex rel., Department of Consumer Credit ("Petitioner") and the Respondent, Autohaus Sports Cars, Inc. d/b/a Autohaus Sports Cars, ("Respondent") voluntarily enter into this Consent Order as an informal disposition of this individual proceeding to avoid litigation. The Respondent agrees to waive its right to a hearing under the Oklahoma Administrative Procedures Act and both parties agree as follows:

- (1) The Petitioner restates and incorporates by reference the allegations made by the Petitioner in the Notice of Hearing filed in this matter.
 - i. The Respondent is registered as a domestic for profit corporation in the State of Oklahoma, Oklahoma Secretary of State filing number 1900289668, active filing status.
 - ii. The Respondent transacts business at 304 S. Sooner Road, Midwest City, OK 73110.
 - iii. On August 30, 2016, a consumer credit examiner entered the business premises of the Respondent and spoke to Mr. Paul Crossfield, who was identified as the owner of the car lot by a salesman that first approached the examiner as she entered the premises.
 - iv. The examiner asked Mr. Crossfield if the location

engaged in in-house financing. Mr. Crossfield stated that the location does engage in in-house financing. He also mentioned that a 1 ½ years ago, he received a notice from the Department with information about a notification permit. He stated that he only needed a notification permit if his sales were \$100,000 or more. He told the examiner that he didn't think that he needed a permit since they were not doing that much business. The examiner suggested to him to visit the Department's website for more information.

- v. Mr. Crossfield provided the examiner with a copy of a current Retail Installment Contract, Security Agreement and Disclosure Statement.
- vi. As of August 30, 2016, the Respondent was not licensed in the State of Oklahoma pursuant to the provisions of 14A O.S. §§ 6-201 through 6-203 of the UCCC. 14A O.S. § 6-203(2).
- vii. The Respondent is licensed as of September 8, 2016. The Department received Respondent's notification filing application on September 1, 2016. Respondent was issued a notification filing permit on September 8, 2016.
- viii. The Respondent did not file notification pursuant to the provisions of Section 6-201 of the UCCC, on or before January 31, 2016.
- (2) The Respondent does not admit to the allegations made by the Petitioner in the Notice of Hearing filed in this matter, and incorporated by reference in this Consent Order.
- (3) The Respondent agrees to pay all applicable registration/application fees and a \$1,000.00 civil penalty, payable to the Oklahoma Department of Consumer Credit, on or before October 31, 2016.
- (4) The payment shall be made payable by check or money order to the Oklahoma Department of Consumer Credit, shall indicate the payment is for Case Number 16-0160-DIS and shall be addressed to the attention of Roy John Martin, General Counsel, Department of Consumer Credit, 3613 N.W. 56th Street, Suite 240, Oklahoma City, Oklahoma 73112.
