CONSENT ORDER

Petitioner, State of Oklahoma *ex rel.* Department of Consumer Credit ("Petitioner") and the Respondent, Marie's Route 66 Motor Co., ("Respondent") voluntarily enter into this Consent Order as an informal disposition of this individual proceeding to avoid litigation. Respondent agrees to waive its right to a hearing under the Oklahoma Administrative Procedures Act and both parties agree as follows:

(1) Petitioner restates and incorporates by reference the allegations made by Petitioner in the Notice of Hearing filed in this matter.

- a. The Respondent has no active business filing with the Oklahoma Secretary of State.
- b. The Respondent transacts business at 4217 East 11th Street, Tulsa, OK 74112.
- c. On November 15, 2016, Chris Williams, a consumer credit examiner, entered the Respondent's business premises and spoke to Walter Lopez, Manager.
- d. The examiner asked Mr. Lopez if he could discuss financing options. Mr. Lopez advised they offer their own financing and buy here pay here services. Mr. Lopez would not provide the examiner with copies of applications or contracts.
- e. On December 20, 2016, the Petitioner issued a subpoena duces tecum to Marie Bruner, Marie's Route 66 Motor

Company at the address of 4217 E. 11th Street, Tulsa, OK 74112. Respondent was requested to submit documents no later than January 9, 2017. Five (5) Retail Installment Sale Contracts were received on January 25, 2016.

- f. The copy of the Retail Installment Sale Contract for A. Jazayetli lists the purchase of a 2010 Ford Focus. The Seller is listed as Marie's Route 66 Motor Co. with the business address listed. The terms of the contract are 57 monthly payments in the amount of \$100.00 with the first payment scheduled on May 6, 2016. Total sales price of the vehicle is \$7,736.39. An annual percentage rate of 21% is listed on the sale contract.
- g. The additional four (4) Retail Installment Sales Contracts received all indicate the Seller as Marie's Route 66 Motor Co. with the business address listed.
- h. As of November 29, 2016, the Respondent is licensed in the State of Oklahoma pursuant to the provisions of 14A O.S. §§ 6-201 through 6-203 of the UCCC. 14A O.S. § 6-203(2). The notification filing license application was received on November 21, 2016.
- i. The Respondent did not file notification pursuant to the provisions of Section 6-201 of the UCCC, on or before January 31, 2016.

(2) Respondent does not admit to the allegations made by the Petitioner in the Notice of Hearing filed in this matter, and incorporated by reference in this Consent Order.

(3) In addition, the Respondent agrees to pay a \$500.00 civil penalty, payable to the Oklahoma Department of Consumer Credit, in the following terms:

- (a) The Respondent agrees to make five (5) monthly installment payments in the amount of \$100.00 no later than the 1st of the month until paid in full. First installment payment is due on or before April 1, 2017.

(b) If the Respondent misses a monthly payment, the Respondent's license will be suspended and the remaining balance will be due in full.

(4) The payment shall be made payable by check or money order to the Oklahoma Department of Consumer Credit, shall indicate the payment is for Case Number 16-0257-DIS and shall be addressed to the attention of J. Steven Coates, General Counsel, Department of Consumer Credit, 3613 N.W. 56th Street, Suite 240, Oklahoma City, Oklahoma 73112.

(5) A file stamped copy of this Consent Order will be returned to Respondent upon signature of the Administrator of the Department of Consumer Credit or the Deputy Administrator of the Department Consumer Credit.

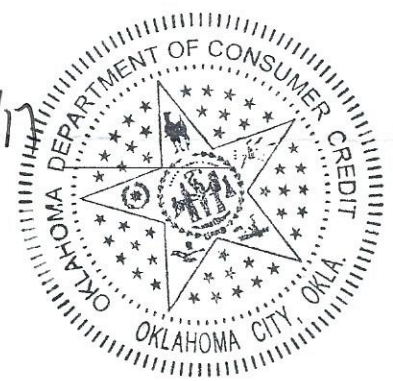
