CONSENT ORDER

- (1) Petitioner restates and incorporates by reference the allegations made by the Petitioner in the Notice of Hearing filed in this matter.

 - ii. Respondent is licensed as a mortgage loan originator in the State of Oklahoma pursuant to the SAFE Act with the following licensing information indicated by NMLS:
 - a. Oklahoma license number ML007840.
 - b. NMLS unique identifier number/company ID

- c. Mailing address of record at 4108 Patmos Rd., Hope, AR 71801.
- iii. Respondent's license renewal fee was not paid on or before December 1, 2016.
- iv. Respondent requested a renewal of their license on December 16, 2016.
- v. Respondent has failed to pay \$150.00 in license renewal fees.
- (2) Respondent does not admit to the allegations made by the Petitioner in the Notice of Hearing filed in this matter, and incorporated by reference in this Consent Order.
- (3) Respondent agrees to pay the late fee of \$150.00 and a \$250.00 civil penalty, for a total of \$400.00, payable to the Oklahoma Department of Consumer Credit, on or before July 7, 2017.
- (4) The payment shall be made payable by check or money order to the Oklahoma Department of Consumer Credit, shall indicate the payment is for Case Number 17-0150-DIS and shall be addressed to the attention of J. - (5) A file stamped copy of this Consent Order will be returned to Respondent upon signature of the Administrator of the Department of Consumer Credit or the Deputy Administrator of the Department Consumer Credit.
- (6) If Respondent fails to comply with the terms of this Consent Order, the Administrator of the Department of Consumer Credit is authorized to file an application to enforce this Consent Order in the District Court of Oklahoma County, Oklahoma in accordance with the provisions of 59 O.S. § 2095.17(c).
