CONSENT ORDER

- Petitioner restates and incorporates by reference the allegations made by Petitioner in the Notice of Hearing filed in this matter.
 - Respondent is a domestic limited liability company a. under the State of Oklahoma, Oklahoma Secretary of State filing number 3512185342, active filing status.
 - Respondent transacts business at 333 N. Butler Road, b. Pauls Valley, OK 73075.
 - On July 12, 2017, Jimmie Ray and Michael Thompson, C. consumer credit examiners, entered Respondent's business premises and spoke to Eric Goodale, Finance Director.
 - The examiners asked Mr. Goodale about consumer auto d. financing options offered to consumers when thev purchase vehicles at the dealership.

advised Respondent does offer finance and cash options to purchase automobiles. Mr. Goodale advised Respondent utilizes Ford Motor Credit, TFCU, and TD Auto Finance, as a few of the lenders used for financing. Upon request, the examiners viewed the retail installment contracts and asked if they could take a photo copy of the retail installment contracts. Respondent's website shows consumers can complete a financing application online.

- e. The copy of the Retail Installment Sale Contract for M. Harris lists the purchase of a 2017 Ford Focus. The Seller is listed as Badger Valley Investments, LLC with the business address of 2103 West Grant, Pauls Valley, OK 73075 listed. The terms of the contract are 59 monthly payments in the amount of \$285.49 with the first payment due on August 25, 2017. Total sales price of the vehicle is \$20,379.01. The interest rate is listed as 0.00%.
- f. Respondent is not a supervised financial organization or a person holding a license to make supervised loans issued under 14A O.S. § 3-501 et seq.
- g. As of November 9, 2017, Respondent is licensed in the State of Oklahoma pursuant to the provisions of 14A 0.S. §§ 6-201 through 6-203 of the UCCC. The notification filing license application was received on November 3, 2017.
- h. Respondent did not file notification pursuant to the provisions of Section 6-202 of the UCCC, on or before January 31, 2017.
- (2) C. Craig Cole of C. Craig Cole & Associates has entered his appearance as attorney of record for Respondent.
- (3) Counsel for Respondent accepted service of Notice and Order of Hearing on behalf of Respondent.
- (4) Respondent hereby waives any and all potential claims of deficiency of notice and/or hearing requirements under the Oklahoma Administrative Procedures Act.
- (5) Respondent does not admit to the allegations made by the Petitioner in the Notice of Hearing filed in this matter,

and incorporated by reference in this Consent Order.

- (6) Respondent agrees to pay a \$400.00 civil penalty, payable to the Oklahoma Department of Consumer Credit, on or before December 8, 2017.
- (7) The payment shall be made payable by check or money order to the Oklahoma Department of Consumer Credit, shall indicate the payment is for Case Number 17-0320-DIS and shall be addressed to the attention of John T. Coyne, Chief Enforcement Attorney, Department of Consumer Credit, 3613 N.W. 56th Street, Suite 240, Oklahoma City, Oklahoma 73112.
- (8) A file stamped copy of this Consent Order will be returned to Respondent upon signature of the Administrator of the Department of Consumer Credit or the Deputy Administrator of the Department Consumer Credit.
- (9) If Respondent fails to comply with the terms of this Consent Order, the Administrator of the Department of Consumer Credit is authorized to file an application to enforce this Consent Order in the District Court of Oklahoma County, Oklahoma in accordance with the provisions of 14 O.S. § 6-113(4).
