CONSENT ORDER

ex rel. Respondent agrees to waive its right to a hearing under the Oklahoma Administrative Procedures Act and both parties agree as follows:

- Petitioner restates and incorporates by reference the allegations made by Petitioner in the Notice of Hearing filed in this matter.
 - Respondent is a domestic limited liability company a. under the jurisdiction of the State of Oklahoma, Oklahoma Secretary of State filing number 3512380497, active filing status.
 - Respondent transacts business at 121 E. Waterloo Rd., b. #12, Edmond, OK 73034.
 - On January 29, 2018, Jimmie Ray and Michael Thompson, C. consumer credit investigators, went to Respondent's business premises and spoke to the manager, Lane. The investigators asked if the owner is Joshua Williams. Lane advised yes. The investigators asked to review new member contracts. Lane advised she could not print the contracts off the computer. The investigators reviewed the contracts on the computer and asked to have the owner email a copy of the requested contracts. Later that afternoon, Joshua Williams

emailed an executed contract.

- d. Respondent previously held license number SPA00682 which expired December 31, 2017.
- e. As of the date of the Notice, Respondent is operating under an expired Health Spa license.
- (2) Respondent does not admit to the allegations made by Petitioner in the Notice of Hearing filed in this matter, and incorporated by reference in this Consent Order, except that Respondent admits the facts necessary to establish the Department's jurisdiction over Respondent and the subject matter of this action.
- (3) Respondent will submit a Health Spa license application and pay all applicable registration/application fees to the Department on or before March 18, 2019. In addition, Respondent agrees to pay a \$1,500.00 civil penalty, payable to the Oklahoma Department of Consumer Credit on or before March 18, 2019.
- (4) The payment shall be made payable by check or money order to the Oklahoma Department of Consumer Credit, shall indicate the payment is for Case Number 18-0044-DIS and shall be addressed to the attention of John T. Coyne, Chief Enforcement Attorney, Department of Consumer Credit, 3613 N.W. 56th Street, Suite 240, Oklahoma City, Oklahoma 73112.
- (5) A file stamped copy of this Consent Order will be returned to the Respondent upon signature of the Administrator of the Department of Consumer Credit or the Deputy Administrator of the Department Consumer Credit.
- (6) If Respondent fails to comply with the terms of this Consent Order, the Administrator of the Department of Consumer Credit is authorized to file an application to enforce this Consent Order in the District Court of Oklahoma County, Oklahoma in accordance with the provisions of 14 O.S. § 6-113(4).
