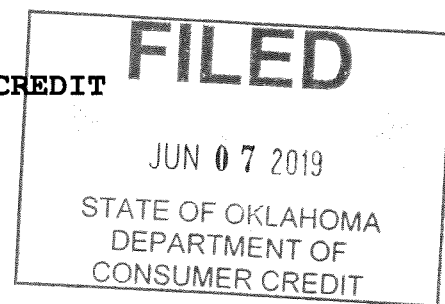

CONSENT ORDER

Petitioner, State of Oklahoma *ex rel.* Department of Consumer Credit ("Petitioner") and Respondent, Fitness Clubs of OK Corp d/b/a Anytime Fitness Tahlequah, ("Respondent") voluntarily enter into this Consent Order as an informal disposition of this individual proceeding to avoid litigation. Respondent agrees to waive its right to a hearing under the Oklahoma Administrative Procedures Act and both parties agree as follows:

(1) Petitioner restates and incorporates by reference the allegations made by Petitioner in the Notice of Hearing filed in this matter.

a. Respondent is a domestic for profit business corporation under the jurisdiction of the State of Oklahoma, Oklahoma Secretary of State filing number 1912524919, inactive filing status.

b. Respondent transacts business at 1741 S. Muskogee Ave., Ste. 5, Tahlequah, OK 74464.

c. On March 13, 2019, Jimmie Ray and Michael Thompson, Consumer Credit Investigators, conducted an investigation of Respondent at Respondent's business location. The investigators spoke to Blake Davidson, manager. The investigators asked Mr. Davidson if Respondent has been conducting business and signing up new members in 2019. Mr. Davidson advised Respondent was conducting business and

signing up new members in 2019, and that Respondent has roughly 815 total members. Upon request, the investigators reviewed and scanned member contracts from 2019. The member contracts list 12-month membership fee and \$30 charge for a key fob to allow 24-hour access. The fees are debited via EFT from the member's financial institution.

d. Respondent previously held license number SPA00757 which expired December 31, 2018.

e. As of the date of the Notice, Respondent is operating under an expired Health Spa license.

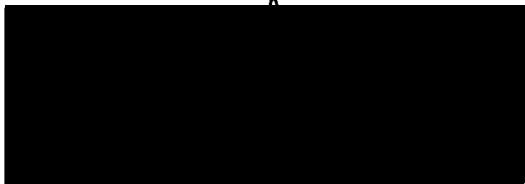
(2) Respondent does not admit to the allegations made by Petitioner in the Notice of Hearing filed in this matter, and incorporated by reference in this Consent Order, except that Respondent admits the facts necessary to establish the Department's jurisdiction over Respondent and the subject matter of this action.

(3) Respondent will submit a Health Spa license application and pay all applicable registration/application fees to the Department on or before June 3, 2019. In addition, Respondent agrees to pay a \$3,250.00 civil penalty, payable in twenty-six (26) installments of \$125.00 each, with first installment payment due on or before June 3, 2019, and subsequent payments due by the third day of the month for 25 months thereafter.

(4) The payments shall be made payable by check or money order to the Oklahoma Department of Consumer Credit, shall indicate the payment is for Case Number 19-0023-DIS and shall be addressed to the attention of John T. Coyne, Chief Enforcement Attorney, Department of Consumer Credit, 3613 N.W. 56th Street, Suite 240, Oklahoma City, Oklahoma 73112.

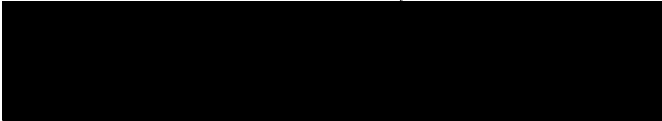
(5) A file stamped copy of this Consent Order will be returned to the Respondent upon signature of the Administrator of the Department of Consumer Credit or the Deputy Administrator of the Department Consumer Credit.

(6) If Respondent fails to comply with the terms of this Consent Order, the Administrator of the Department of Consumer Credit is authorized to file an application to enforce this Consent Order in the District Court of Oklahoma County, Oklahoma in accordance with the provisions of 14 O.S. § 6-113(4).

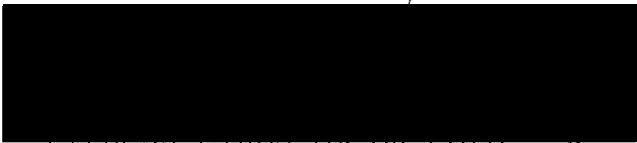

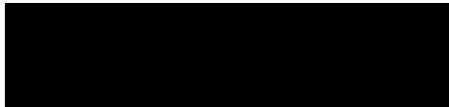
