CONSENT ORDER

Petitioner, State of Oklahoma *ex rel.* Department of Consumer Credit ("Petitioner") and Respondent, Anytime Fitness (5901 S. Sooner Rd., OKC, OK 73135), voluntarily enter into this Consent Order as an informal disposition of this individual proceeding to avoid litigation. Respondent agrees to waive its right to a hearing under the Oklahoma Administrative Procedures Act and both parties agree as follows:

(1) Petitioner restates and incorporates by reference the allegations made by Petitioner in the Notice of Hearing filed in this matter.

i. Respondent has no known business filing on the Oklahoma Secretary of State's website.

ii. Respondent transacts business at 5901 S. Sooner Rd., Oklahoma City, OK 73135.

iii. On July 10, 2023, Jimmie Ray and Michael Thompson, Consumer Credit Investigators, went to Respondent's business premises and spoke to Jeff Trimble, owner. Mr. Trimble advised he has owned the location for 6 years and Respondent has roughly 800 members. Mr. Trimble advised Respondent offers 12-month and 18-month packages for members. Upon request, the investigators reviewed and scanned a member agreement. The agreement was initiated on July 8, 2023, and ends on July 7, 2024, and has monthly auto-draft from the member's bank account. A review of Respondent's website lists member packages and

pricing.

iv. Respondent had a Health Spa license for this location, license number SPA00361, issued October 19, 2006, and expired December 31, 2011.

v. As of the date of the Notice, Respondent did not have a Health Spa license for this location.

vi. Respondent submitted a Health Spa license application and filing fee to Petitioner on August 14, 2023.

(2) Respondent does not admit to the allegations made by Petitioner in the Notice of Hearing filed in this matter and incorporated by reference in this Consent Order, except that Respondent admits the facts necessary to establish the Department's jurisdiction over Respondent and the subject matter of this action.

(3) Respondent agrees to pay a \$500.00 civil penalty payable to the Oklahoma Department of Consumer Credit, on or before September 28, 2023.

(4) The payment shall be made payable by check or money order to the Oklahoma Department of Consumer Credit, shall indicate the payment is for Case Number 23-0024-DIS and shall be addressed to the attention of John T. Coyne, Chief Enforcement Attorney, Department of Consumer Credit, 629 NE 28th Street, Oklahoma City, Oklahoma 73105.

(5) A file stamped copy of this Consent Order will be returned to Respondent upon signature of the Administrator of the Department of Consumer Credit or the Deputy Administrator of the Department Consumer Credit.

(6) If Respondent fails to comply with the terms of this Consent Order, the Administrator of the Department of Consumer Credit is authorized to file an application to enforce this Consent Order in the District Court of Oklahoma County, Oklahoma in accordance with the provisions of 14 O.S. § 6-113(4).

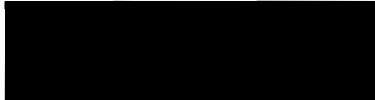
