CONSENT ORDER

Petitioner, State of Oklahoma ex rel. Department of Consumer Credit ("Petitioner") and Respondent, Endless Fitness LLC, ("Respondent") voluntarily enter into this Consent Order as an informal disposition of this individual proceeding to avoid litigation. Respondent agrees to waive its right to a hearing under the Oklahoma Administrative Procedures Act and both parties agree as follows:

(1) Petitioner restates and incorporates by reference the allegations made by the Petitioner in the Notice of Hearing filed in this matter.

i. Respondent is a domestic limited liability company under the jurisdiction of the State of Oklahoma, Oklahoma Secretary of State filing number 3512733484, active filing status.

ii. Respondent transacts business at 15306 S. Memorial Rd., Bixby, OK 74008.

iii. On June 11, 2024, Jimmie Ray and Michael Thompson, Consumer Credit Investigators, performed an investigation of Respondent. The Investigators spoke to Luke Spaulding, the receptionist. Mr. Spaulding advised Respondent is locally owned by Logan and Paige Riley and has been in business since 2019. Mr. Spaulding also stated members sign up for packages via paper application. Respondent's website lists a \$60 dollar enrollment fee for some of the pricing packages. The members can sign up for month to month, 3-

month and 12-month plans. Upon request, the Investigators reviewed and scanned a copy of an active 3-month member agreement plan which included a \$60 membership enrollment fee. A review of the Department of Consumer Credit database shows Endless Fitness LLC does not have a Health Spa license with the Department.

iv. As of the date of the Notice, Respondent was operating without a Health Spa License.

v. On August 15, 2024, Petitioner received a Health Spa application and filing fee from Respondent.

(2) Respondent does not admit to the allegations made by the Petitioner in the Notice of Hearing filed in this matter, and incorporated by reference in this Consent Order, except that Respondent admits the facts necessary to establish the Department's jurisdiction over Respondent and the subject matter of this action.

(3) Respondent agrees to pay a civil penalty of \$2,500.00, payable to the Oklahoma Department of Consumer Credit, on or before August 29, 2024.

(4) The payment shall be made payable by check or money order to the Oklahoma Department of Consumer Credit, shall indicate the payment is for Case Number 24-0052-DIS and shall be addressed to the attention of John T. Coyne, Chief Enforcement Counsel, Department of Consumer Credit, 629 NE 28th Street, Oklahoma City, Oklahoma 73105.

(5) A file stamped copy of this Consent Order will be returned to Respondent upon signature of the Administrator of the Department of Consumer Credit or the Deputy Administrator of the Department Consumer Credit.

(6) If Respondent fails to comply with the terms of this Consent Order, the Administrator of the Department of Consumer Credit is authorized to file an application to enforce this Consent Order in the District Court of Oklahoma County, Oklahoma in accordance with the provisions of 59 O.S. § 2095.17(c).


