CONSENT ORDER

Petitioner, State of Oklahoma ex rel. Department of Consumer Credit ("Petitioner") and Respondent, Bartlesville Ford Company Inc., d/b/a Doenges Toyota, ("Respondent") voluntarily enter into this Consent Order as an informal disposition of this individual proceeding to avoid litigation. Respondent agrees to waive its right to a hearing under the Oklahoma Administrative Procedures Act and both parties agree as follows:

- (1) Petitioner restates and incorporates by reference the allegations made by the Petitioner in the Notice of Hearing filed in this matter.
 - i. Respondent is a domestic business corporation under the jurisdiction of the State of Oklahoma, Oklahoma Secretary of State filing number 1900126070; active filing status.
 - ii. Respondent transacts business at 1911 SE Washington Blvd. Bartlesville, OK 74006.
 - iii. On March 19, 2024, Consumer Credit Investigators, Jimmie Ray and Michael Thompson, performed an investigation of Respondent and spoke with Kaylee Henshaw, Sales Manager. The Investigators asked Ms. Henshaw if Respondent offered financing options for consumers. Ms. Henshaw advised Respondent utilizes Toyota Motor Credit, Arvest Bank and Santander as a few of the consumer finance options to purchase vehicles and has been conducting business at the

location for 15 years. Upon request, the Investigators viewed and scanned an executed retail installment sales contract dated 2/23/2024. The contract listed 72 monthly payments of \$976.90 with a 7.04% annual percentage rate and assigned to Toyota Motor Credit Corp. Ms. Henshaw advised the consumers sign the financing paperwork at Respondent's location but can complete a financing application online.

- iv. Respondent is not a supervised financial organization or a person holding a license to make supervised loans issued under 14A O.S. \S 3-501 et seq.
- v. As of the date of the Notice, Respondent was not licensed in the State of Oklahoma pursuant to the provisions of 14A O.S. §§ 6-201 through 6-203 of the UCCC. 14A O.S. § 6-203(2).
- vi. Respondent failed to pay the notification license filing fee for each business location pursuant to OKLA. ADMIN. CODE § 160:5-1-2(2) (A).
- vii. Petitioner received a Notification license application and filing fee from Respondent on May 17, 2024.
- (2) Respondent does not admit to the allegations made by the Petitioner in the Notice of Hearing filed in this matter, and incorporated by reference in this Consent Order, except that Respondent admits the facts necessary to establish the Department's jurisdiction over Respondent and the subject matter of this action.
- (3) Respondent agrees to pay a civil penalty of \$500.00, payable to the Oklahoma Department of Consumer Credit, on or before June 3, 2024.
- (4) The payment shall be made payable by check or money order to the Oklahoma Department of Consumer Credit, shall indicate the payment is for Case Number 24-0027-DIS and shall be addressed to the attention of John T. Coyne, Chief Enforcement Counsel, Department of Consumer Credit, 629 NE 28th Street, Oklahoma City, Oklahoma 73105.
- (5) A file stamped copy of this Consent Order will be returned to Respondent upon signature of the Administrator of the Department of Consumer Credit or the Deputy Administrator of the Department Consumer Credit.
