CONSENT ORDER

Petitioner, State of Oklahoma ex rel. Department of Consumer Credit ("Petitioner") and Respondent, Parkway Auto Sales LLC, ("Respondent") voluntarily enter into this Consent Order as an informal disposition of this individual proceeding to avoid litigation. Respondent agrees to waive its right to a hearing under the Oklahoma Administrative Procedures Act and both parties agree as follows:

- (1) Petitioner restates and incorporates by reference the allegations made by the Petitioner in the Notice of Hearing filed in this matter.
 - i. Respondent is a domestic limited liability company under the jurisdiction of the State of Oklahoma, Oklahoma Secretary of State filing number 3513059352; active filing status.
 - ii. Respondent transacts business at 3420 S. May Ave., Oklahoma City, OK 73119.
 - iii. On September 11, 2024, Consumer Credit Investigators Jimmie Ray and Michael Thompson arrived at Respondent's location and spoke to Manny Trejo. Mr. Trejo advised Respondent offers financing for customers to purchase vehicles at the dealership. Mr. Trejo stated that customers sign the financial paperwork at Respondent's location. The Investigators requested to review customers signed financial documents for Respondent and Auto Right Auto Group LLC. Mr. Trejo advised the financial documents for

Auto Right Auto Group LLC were indeed stored at Respondent's location, but the only person that had access to the documents was not available. The Investigators thanked Mr. Trejo and stated that Petitioner's legal department would request the contracts. A review of Respondent's website shows customers can complete a credit application online.

- iv. On March 17, 2025, Petitioner received requested contracts from Respondent. A review of a retail installment contract for a customer lists Respondent as the seller and is assigned to a lender.
- v. As of the date of the Notice, Respondent was not licensed in the State of Oklahoma pursuant to the provisions of 14A O.S. §§ 6-201 through 6-203 of the UCCC. 14A O.S. § 6-203(2).
- vi. Respondent failed to pay the notification license filing fee for each business location pursuant to OKLA. ADMIN. CODE § 160:5-1-2(2) (A).
- vii. On May 2, 2025, Petitioner received a Notification license application and filing fee from Respondent. Notification license number 89711 was issued to Respondent on May 6, 2025.
- (2) Respondent does not admit to the allegations made by the Petitioner in the Notice of Hearing filed in this matter, and incorporated by reference in this Consent Order, except that Respondent admits the facts necessary to establish the Department's jurisdiction over Respondent and the subject matter of this action.
- (3) Respondent agrees to pay a civil penalty of \$750.00, payable to the Oklahoma Department of Consumer Credit, on or before May 30, 2025.
- (4) The payment shall be made payable by check or money order to the Oklahoma Department of Consumer Credit, shall indicate the payment is for Case Number 25-0003-DIS and shall be addressed to the attention of John T. Coyne, Chief Enforcement Counsel, Department of Consumer Credit, 629 NE 28th Street, Oklahoma City, Oklahoma 73105.

- (5) A file stamped copy of this Consent Order will be returned to Respondent upon signature of the Administrator of the Department of Consumer Credit or the Deputy Administrator of the Department Consumer Credit.
- (6) If Respondent fails to comply with the terms of this Consent Order, the Administrator of the Department of Consumer Credit is authorized to file an application to enforce this Consent Order in the District Court of Oklahoma County, Oklahoma in accordance with the provisions of 59 O.S. § 2095.17(c).
