**CONSENT ORDER**

Petitioner, State of Oklahoma *ex rel.* Department of Consumer Credit ("Petitioner") and Respondent, Mandalore, LLC dba Anytime Fitness 2185, ("Respondent") voluntarily enter into this Consent Order as an informal disposition of this individual proceeding to avoid litigation. Respondent agrees to waive its right to a hearing under the Oklahoma Administrative Procedures Act and both parties agree as follows:

(1) Petitioner restates and incorporates by reference the allegations made by the Petitioner in the Notice of Hearing filed in this matter.

i. Respondent is a domestic limited liability company under the jurisdiction of the State of Oklahoma, Oklahoma Secretary of State filing number 3513700743, active filing status.

ii. Respondent transacts business at 8003 NW 122<sup>nd</sup> St., Oklahoma City, OK 73142.

iii. On April 16, 2025, Jimmie Ray and Michael Thompson, Consumer Credit Investigators, visited Respondent's location and noticed a phone number on the door, (405) 274-2359, to contact the manager, Brandon Wright. The Investigators called the phone number, spoke to Mr. Wright and requested 10 membership agreements for review. The Investigators gave Mr. Wright their email address to email them the requested contracts. The Investigators took a

photo of the exterior of the business and exited the premises. A review of Respondent's webpage lists 12-month and 18-month membership agreements. On April 24, 2025, the Investigators requested a subpoena for 10 executed membership agreements from Respondent dated from 4/23/2024 thru 4/23/2025. On August 4, 2025, Mr. Wright emailed the requested membership agreements to Petitioner. A review of the agreements shows Respondent is engaged in a program of physical exercise, which includes exercise machines and engaged in the sale of the right or privilege to use exercise equipment or facilities.

iv. At the time of the Investigation on April 16, 2025, Respondent was operating without a Health Spa license.

v. On August 11, 2025, Petitioner received a Health Spa license application and filing fee from Respondent.

vi. On September 12, 2025, license number SPA00891 was to Respondent.

(2) Respondent does not admit to the allegations made by the Petitioner in the Notice of Hearing filed in this matter, and incorporated by reference in this Consent Order, except that Respondent admits the facts necessary to establish the Department's jurisdiction over Respondent and the subject matter of this action.

(3) Respondent agrees to pay a civil penalty of \$1,375.00, payable to the Oklahoma Department of Consumer Credit in five (5) payments of \$275.00 with the following payment schedule:

First payment of \$275.00 due on or before September 29, 2025.

Second payment of \$275.00 due on or before October 29, 2025.

Third payment of \$275.00 due on or before November 29, 2025.

Fourth payment of \$275.00 due on or before December 29, 2025.

Fifth payment of \$275.00 due on or before January 29, 2026.

(4) The payments shall be made payable by check or money order to the Oklahoma Department of Consumer Credit, shall indicate the payment is for Case Number 25-0074-DIS and shall be addressed to the attention of John T. Coyne, Chief Enforcement Counsel, Department of Consumer Credit, 629 NE 28th Street,

Oklahoma City, Oklahoma 73105.

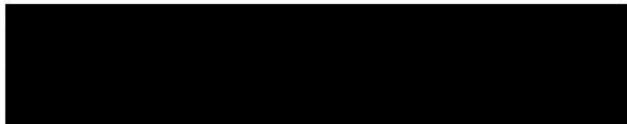
(5) A file stamped copy of this Consent Order will be returned to Respondent upon signature of the Administrator of the Department of Consumer Credit or the Deputy Administrator of the Department Consumer Credit.

(6) If Respondent fails to comply with the terms of this Consent Order, the Administrator of the Department of Consumer Credit is authorized to file an application to enforce this Consent Order in the District Court of Oklahoma County, Oklahoma in accordance with the provisions of 59 O.S. § 2095.17(c).


