CONSENT ORDER

Petitioner, State of Oklahoma ex rel. Department of Consumer Credit ("Petitioner") and Respondent, TEN20THIRTY, LLC d/b/a Club Pilates (Yukon), ("Respondent") voluntarily enter into this Consent Order as an informal disposition of this individual proceeding to avoid litigation. Respondent agrees to waive its right to a hearing under the Oklahoma Administrative Procedures Act and both parties agree as follows:

- (1) Petitioner restates and incorporates by reference the allegations made by the Petitioner in the Notice of Hearing filed in this matter.
 - i. Respondent is a foreign limited liability company under the jurisdiction of the State of Texas, Oklahoma Secretary of State filing number 3713401062, active filing status.
 - ii. Respondent transacts business at 12708 NW 10^{th} St., Ste. 113, Yukon, OK 73099.
 - iii. On June 4, 2025, Consumer Credit Investigators Jimmy Ray and Michael Thompson arrived at On June 4, 2025, arrived at Respondent's location at 12708 NW 10^{TH} Street, Suite 113, Yukon, OK 73099 and spoke to Mel Riggs, the General Manager. The Investigators asked Mr. Riggs how long Respondent has been conducting business and how many active members it has. Mr. Riggs advised Respondent has been open

since February of 2025 with 400 members. Mr. Riggs also stated Respondent's corporate name is Ten20Thirty, LLC and has only one location in Oklahoma. Upon request, Mel emailed membership agreements to the Investigators. A review of section 2 of the membership agreement's summary of terms and account charges shows the members sign up for an initial term of 3 months and then convert to a month-tomonth contract. If the member cancels during the initial 3month term, there is a \$100-dollar early termination fee. Michael and I thanked Mel, exited the building and took an exterior photo as we exited the premises. The review of Respondent's website lists the membership plans for consumers. Respondent is engaged in a program of physical exercise, which includes exercise machines and is engaged in the sale of the right or privilege to use exercise equipment or facilities.

- iv. As of the date of the Notice and Order of Hearing, Respondent was operating without a Health Spa License.
- v. On August 18, 2025, Petitioner received a Health Spalicense application and filing fee from Respondent.
- (2) Respondent does not admit to the allegations made by the Petitioner in the Notice of Hearing filed in this matter, and incorporated by reference in this Consent Order, except that Respondent admits the facts necessary to establish the Department's jurisdiction over Respondent and the subject matter of this action.
- (3) Respondent agrees to pay a civil penalty of \$2,500.00, payable to the Oklahoma Department of Consumer Credit, on or before September 1, 2025.
- (4) The payment shall be made payable by check or money order to the Oklahoma Department of Consumer Credit, shall indicate the payment is for Case Number 25-0061-DIS and shall be addressed to the attention of John T. Coyne, Chief Enforcement Counsel, Department of Consumer Credit, 629 NE 28th Street, Oklahoma City, Oklahoma 73105.
- (5) A file stamped copy of this Consent Order will be returned to Respondent upon signature of the Administrator of the Department of Consumer Credit or the Deputy Administrator of the Department Consumer Credit.
