CONSENT ORDER

Petitioner, State of Oklahoma ex rel. Department of Consumer Credit ("Petitioner") and Respondent, Four Star Fitness Edmond, Inc., ("Respondent") voluntarily enter into this Consent Order as an informal disposition of this individual proceeding to avoid litigation. Respondent agrees to waive its right to a hearing under the Oklahoma Administrative Procedures Act and both parties agree as follows:

- (1) Petitioner restates and incorporates by reference the allegations made by the Petitioner in the Notice of Hearing filed in this matter.
 - i. Respondent is a domestic for profit business corporation under the jurisdiction of the State of Oklahoma, Oklahoma Secretary of State filing number 1912564897, active filing status.
 - ii. Respondent transacts business at 3325 S. Blvd., Ste. 163, Edmond, OK 73013.
 - iii. On August 5, 2025, Jimmie Ray and Michael Thompson, Consumer Credit Investigators, investigated Respondent located at 3325 S. Blvd., Ste. 163, Edmond, OK 73013. The Investigators spoke to Russell Spencer, Sales Rep. Mr. Spencer advised Respondent opened for business in February of 2025. Mr. Spencer advised Respondent has an estimated 1000 active members. The members complete the membership signup in person at Respondent's location, and the

membership can be utilized at any of the locations. The members can sign up for a month to month or 12-month agreement. Upon request, the Investigators reviewed and scanned a copy of an executed 12-month membership agreement which was executed on 8/5/2025 and ends on 9/5/2026 with monthly payments in the amount of \$37.89. A review of Respondent's website shows address, phone number 405-216-3919, exercise equipment and signup package information.

- iv. On September 5, 2025, Petitioner received a Health Spa license application and filing fee from Respondent. License number SPA00896 was issued on October 9, 2025.
- (2) Respondent does not admit to the allegations made by the Petitioner in the Notice of Hearing filed in this matter, and incorporated by reference in this Consent Order, except that Respondent admits the facts necessary to establish the Department's jurisdiction over Respondent and the subject matter of this action.
- (3) Respondent agrees to pay a civil penalty of \$1,500.00, payable to the Oklahoma Department of Consumer Credit, on or before October 30, 2025.
- (4) The payment shall be made payable by check or money order to the Oklahoma Department of Consumer Credit, shall indicate the payment is for Case Number 25-0077-DIS and shall be addressed to the attention of John T. Coyne, Chief Enforcement Counsel, Department of Consumer Credit, 629 NE 28th Street, Oklahoma City, Oklahoma 73105.
- (5) A file stamped copy of this Consent Order will be returned to Respondent upon signature of the Administrator of the Department of Consumer Credit or the Deputy Administrator of the Department Consumer Credit.
- (6) If Respondent fails to comply with the terms of this Consent Order, the Administrator of the Department of Consumer Credit is authorized to file an application to enforce this Consent Order in the District Court of Oklahoma County, Oklahoma in accordance with the provisions of 59 O.S. § 2095.17(c).
