## CONSENT ORDER

Petitioner, State of Oklahoma ex rel. Department of Consumer Credit ("Petitioner") and Respondent, Mission Servicing Residential, Inc., ("Respondent") voluntarily enter into this Consent Order as an informal disposition of this individual proceeding to avoid litigation. Respondent agrees to waive its right to a hearing under the Oklahoma Administrative Procedures Act and both parties agree as follows:

- (1) Petitioner restates and incorporates by reference the allegations made by the Petitioner in the Notice of Hearing filed in this matter.
  - i. Respondent is a foreign for profit business corporation under the jurisdiction of the State of Alabama, Oklahoma Secretary of State filing number 2313863349, active filing status.
  - ii. The licensing system of record for mortgage loan originators, mortgage lenders and mortgage brokers in the State of Oklahoma is NMLS.
  - iii. Respondent is licensed as a mortgage lender in the State of Oklahoma pursuant to the SAFE Act with the following licensing information indicated by NMLS:
    - (a) Oklahoma license number ML017560;
    - (b) NMLS unique identifier number/company ID 64524;

- (c) Mailing address of record at 1425 Greenway Drive, Ste. 625, Irving, TX 75038;
- iv. On August 9, 2025, Respondent submitted an application for an Oklahoma Mortgage Lender license with Petitioner through NMLS. Respondent had a prior license with Petitioner from December 31, 2019 through August 19, 2022, license number ML012664 which was terminated/surrendered on August 19, 2022.
- v. Respondent's Mortgage Call Reports reflect servicing activity of Oklahoma Mortgage Loans from 2024 Quarter 4 through 2025 Quarter 2.
- vi. Respondent serviced Oklahoma Mortgage Loans without holding a valid Oklahoma Mortgage Lender license with Petitioner.
- (2) Respondent does not admit to the allegations made by the Petitioner in the Notice of Hearing filed in this matter, and incorporated by reference in this Consent Order, except that Respondent admits the facts necessary to establish the Department's jurisdiction over Respondent and the subject matter of this action.
- (3) Respondent agrees to pay a civil penalty of \$10,000.00, payable to the Oklahoma Department of Consumer on or before November 24, 2025.
- (4) The payment shall be made payable by check or money order to the Oklahoma Department of Consumer Credit, shall indicate the payment is for Case Number 25-0123-DIS and shall be addressed to the attention of John T. Coyne, Chief Enforcement Counsel, Department of Consumer Credit, 629 NE 28th Street, Oklahoma City, Oklahoma 73105.
- (5) A file stamped copy of this Consent Order will be returned to Respondent upon signature of the Administrator of the Department of Consumer Credit or the Deputy Administrator of the Department Consumer Credit.
- (6) If Respondent fails to comply with the terms of this Consent Order, the Administrator of the Department of Consumer Credit is authorized to file an application to enforce this Consent Order in the District Court of Oklahoma County, Oklahoma in accordance with the provisions of 59 O.S. § 2095.17(c).
