CONSENT ORDER

Petitioner, State of Oklahoma ex rel. Department of Consumer Credit ("Petitioner") and Respondent, Paramount Capital Motors LLC d/b/a Paramount Elite Motors, ("Respondent") voluntarily enter into this Consent Order as an informal disposition of this individual proceeding to avoid litigation. Respondent agrees to waive its right to a hearing under the Oklahoma Administrative Procedures Act and both parties agree as follows:

- (1) Petitioner restates and incorporates by reference the allegations made by the Petitioner in the Notice of Hearing filed in this matter.
 - i. Respondent is a domestic limited liability company under the jurisdiction of the State of Oklahoma, Oklahoma Secretary of State filing number 3512670618; active filing status.
 - ii. Respondent transacts business at 1429 S. Memorial Dr., Tulsa, OK 74112.
 - iii. On August 5, 2025, Consumer Credit Investigators Jimmie Ray and Michael Thompson arrived at Respondent's business location and spoke to Ahed Aamer. The Investigators asked if Respondent offered financing options for the consumers? Mr. Aamer advised Respondent has been in business for 14 months at the location offering vehicle financing for consumers. Mr. Aamer advised the consumers

can complete a financing application online at Respondent's website. Mr. Aamer also advised Respondent utilizes Credit Acceptance and Western Funding as financing sources. The consumers sign the financing paperwork electronically at Respondent's location. Upon request, Mr. Aamer emailed executed retail installment contracts for review. Investigators reviewed a consumer retail contract which lists the creditor-seller as Paramount Capitol Motors LLC, the executed date of 7/9/2025, the amount financed of \$12,674.00, with 66 monthly payments of \$321.88 and assigned to Credit Acceptance Corporation. Mr. Aamer advised Respondent and Paramount Capitol Motors LLC are the same company.

- iv. As of the date of the Notice, Respondent was not licensed in the State of Oklahoma pursuant to the provisions of 14A O.S. §§ 6-201 through 6-203 of the UCCC. 14A O.S. § 6-203(2).
- v. Respondent failed to pay the notification license filing fee for each business location pursuant to OKLA. ADMIN. CODE \S 160:5-1-2(2)(A).
- vi. On October 8, 2025, Petitioner received a Notification License application and filing fee from Respondent.
- (2) Respondent does not admit to the allegations made by the Petitioner in the Notice of Hearing filed in this matter, and incorporated by reference in this Consent Order, except that Respondent admits the facts necessary to establish the Department's jurisdiction over Respondent and the subject matter of this action.
- (3) Respondent agrees to pay a civil penalty of \$750.00, payable to the Oklahoma Department of Consumer Credit, on or before October 30, 2025.
- (4) The payment shall be made payable by check or money order to the Oklahoma Department of Consumer Credit, shall indicate the payment is for Case Number 25-0084-DIS and shall be addressed to the attention of John T. Coyne, Chief Enforcement Counsel, Department of Consumer Credit, 629 NE 28th Street, Oklahoma City, Oklahoma 73105.

- (5) A file stamped copy of this Consent Order will be returned to Respondent upon signature of the Administrator of the Department of Consumer Credit or the Deputy Administrator of the Department Consumer Credit.
- (6) If Respondent fails to comply with the terms of this Consent Order, the Administrator of the Department of Consumer Credit is authorized to file an application to enforce this Consent Order in the District Court of Oklahoma County, Oklahoma in accordance with the provisions of 59 O.S. § 2095.17(c).
