CONSENT ORDER

Petitioner, State of Oklahoma *ex rel.* Department of Consumer Credit ("Petitioner") and Respondent, Star Jewelers, L.L.C., ("Respondent") voluntarily enter into this Consent Order as an informal disposition of this individual proceeding to avoid litigation. Respondent agrees to waive its right to a hearing under the Oklahoma Administrative Procedures Act and both parties agree as follows:

(1) Petitioner restates and incorporates by reference the allegations made by the Petitioner in the Notice of Hearing filed in this matter.

i. Respondent is a domestic limited liability company under the jurisdiction of the State of Oklahoma, Oklahoma Secretary of State filing number 3512110124, active filing status.

ii. Respondent transacts business at 120 S. Main St., Broken Arrow, OK 74012.

iii. On September 3, 2025, Jimmie Ray and Michael Thompson, Consumer Credit Investigators, arrived at Respondent's location and spoke to Kay Thompson, a Sales Representative. The Investigators asked if Respondent buys gold from consumers? Ms. Thompson advised Respondent has been in operation for 52 years and occasionally purchases gold from consumers for cash. Upon request, the Investigators viewed and photographed a bill of sale and receipt dated 9/2/2025 for a consumer selling two ladies diamond gold rings and

one dad gold ring for \$160.00 to Respondent for cash. Ms. Thompson advised Respondent holds the items purchased for 30 days. A review of Respondent's webpage advertises "WE BUY GOLD Bring us your Gold Jewelry and we will write you a CHECK on the spot."

iv. A review of Petitioner's database showed Respondent has an active notification license number 86099 with Petitioner. The database also showed Respondent had a notification license number 62401 that expired on 1/31/2015 and was issued in 2011.

v. As of the date of the Notice and Order of Hearing, Respondent was not licensed as a precious metal and gem dealer.

vi. On March 23, 2026, Petitioner received a Precious Metal and Gem Dealer license application from Respondent.

(2) Respondent does not admit to the allegations made by the Petitioner in the Notice and Order of Hearing filed in this matter, and incorporated by reference in this Consent Order, except that Respondent admits the facts necessary to establish the Department's jurisdiction over Respondent and the subject matter of this action.


(3) Respondent agrees to pay a civil penalty of \$2,500.00, payable to the Oklahoma Department of Consumer Credit, on or before April 1, 2026.

(4) The payment shall be made payable by check or money order to the Oklahoma Department of Consumer Credit, shall indicate the payment is for Case Number 25-0096-DIS and shall be addressed to the attention of John T. Coyne, Chief Enforcement Counsel, Department of Consumer Credit, 629 NE 28th Street, Oklahoma City, Oklahoma 73105.

(5) A file stamped copy of this Consent Order will be returned to Respondent upon signature of the Administrator of the Department of Consumer Credit or the Deputy Administrator of the Department Consumer Credit.

(6) If Respondent fails to comply with the terms of this Consent Order, the Administrator of the Department of Consumer Credit is authorized to file an application to enforce this Consent Order in the District Court of Oklahoma County, Oklahoma

in accordance with the provisions of 59 O.S. § 1528(H).
