## CONSENT ORDER

Petitioner, State of Oklahoma ex rel. Department of Consumer Credit ("Petitioner") and Respondent, CP Studio OK Edmond LLC d/b/a Club Pilates, ("Respondent") voluntarily enter into this Consent Order as an informal disposition of this individual proceeding to avoid litigation. Respondent agrees to waive its right to a hearing under the Oklahoma Administrative Procedures Act and both parties agree as follows:

- (1) Petitioner restates and incorporates by reference the allegations made by the Petitioner in the Notice of Hearing filed in this matter.
  - i. Respondent is a domestic limited liability company under the jurisdiction of the State of Oklahoma, Oklahoma Secretary of State filing number 3513598008, active filing status.
  - ii. Respondent transacts business at 15124 Lleytons Court, Ste. 105, Edmond, OK 73013.
  - iii. On June 4, 2025, Jimmie Ray and Michael Thompson, Consumer Credit Investigators, visited Respondent's location and spoke to the manager, Jazmyn Montgomery. The Investigators asked Ms. Montgomery how long Respondent has been conducting business and the number of members. Ms. Montgomery advised Respondent has been open since May of 2025 with 500 members. Ms. Montgomery also stated the corporate name is CP Studio OK Edmond LLC which owns

Respondent and Respondent's location in Nichols Hills, Oklahoma City. Upon request, the Investigators viewed the 4 and 8 pack membership agreements. The review of section 2 of the membership agreements summary of terms and account charges shows the members sign up for an initial term of 3 months and then convert to a month-to-month contract. If the member cancels during the initial 3-month term, there is a \$100-dollar early termination fee. The review of Respondent's webpage lists the membership plans for consumers. Respondent is engaged in a program of physical exercise, which includes exercising machines and engaged in the sale of the right or privilege to use exercise equipment or facilities.

- iv. Respondent had a Health Spa license with Petitioner which was issued on 12/8/2021 and expired on 12/31/2024.
- v. As of the date of the Notice and Order of Hearing, Respondent was operating without a Health Spa License.
- vi. On August 14, 2025, Petitioner received a Health Spa license application and filing fee from Respondent. License number SPA00893 was issued to Respondent on August 15, 2025.
- (2) Respondent does not admit to the allegations made by the Petitioner in the Notice of Hearing filed in this matter, and incorporated by reference in this Consent Order, except that Respondent admits the facts necessary to establish the Department's jurisdiction over Respondent and the subject matter of this action.
- (3) Respondent agrees to pay a civil penalty of \$1,375.00, payable to the Oklahoma Department of Consumer Credit, on or before September 26, 2025.
- (4) The payment shall be made payable by check or money order to the Oklahoma Department of Consumer Credit, shall indicate the payment is for Case Number 25-0059-DIS and shall be addressed to the attention of John T. Coyne, Chief Enforcement Counsel, Department of Consumer Credit, 629 NE 28th Street, Oklahoma City, Oklahoma 73105.

- (5) A file stamped copy of this Consent Order will be returned to Respondent upon signature of the Administrator of the Department of Consumer Credit or the Deputy Administrator of the Department Consumer Credit.
- (6) If Respondent fails to comply with the terms of this Consent Order, the Administrator of the Department of Consumer Credit is authorized to file an application to enforce this Consent Order in the District Court of Oklahoma County, Oklahoma in accordance with the provisions of 59 O.S. § 2095.17(c).
