CONSENT ORDER

Petitioner, State of Oklahoma *ex rel.* Department of Consumer Credit ("Petitioner") and Respondent, Famian Fittest Yet, LLC d/b/a Hotworx (Owasso), ("Respondent") voluntarily enter into this Consent Order as an informal disposition of this individual proceeding to avoid litigation. Respondent agrees to waive its right to a hearing under the Oklahoma Administrative Procedures Act and both parties agree as follows:

(1) Petitioner restates and incorporates by reference the allegations made by the Petitioner in the Notice of Hearing filed in this matter.

i. Respondent is a domestic limited liability company under the jurisdiction of the State of Oklahoma, Oklahoma Secretary of State filing number 3513022977, active filing status.

ii. Respondent transacts business at 9045 N. 121st E. Ave, Ste. 700, Owasso, OK 74055.

iii. On September 3, 2025, Jimmie Ray and Michael Thompson, Consumer Credit Investigators, visited Respondent's location and spoke with Georgia, an employee. Georgia stated Respondent has been in business since 2019 and Respondent's corporate name is Famian Fittest Yet, LLC. Georgia advised that members can sign up online at Respondent's website. Upon request, the Investigators reviewed and copied a membership agreement dated

10/08/2024. On October 15, 2025, the Investigators called Breanna Lavender, Respondent's manager, and requested an updated membership agreement. Ms. Lavender emailed a membership agreement dated 10/10/25 which showed payment of \$79.00 per month and an initial enrollment fee of \$4.00. If the member cancels before the end of the initial term, the member will be liable for a \$99-dollar early cancellation fee. Respondent is engaged in a program of physical exercise, which includes a weight-lifting room, exercising machines, and is engaged in the sale of the right or privilege to use exercise equipment or facilities. A review of Petitioner's database showed Respondent did not have a Health Spa license with Petitioner.

iv. As of the date of the Notice and Order of Hearing, Respondent was operating without a Health Spa License.

v. On March 11, 2026, Petitioner received a Health Spa license application and filing fee from Respondent.

(2) Respondent does not admit to the allegations made by the Petitioner in the Notice of Hearing filed in this matter, and incorporated by reference in this Consent Order, except that Respondent admits the facts necessary to establish the Department's jurisdiction over Respondent and the subject matter of this action.

(3) Respondent agrees to pay a civil penalty of \$1,250.00, payable to the Oklahoma Department of Consumer Credit, on or before March 30, 2026.

(4) The payment shall be made payable by check or money order to the Oklahoma Department of Consumer Credit, shall indicate the payment is for Case Number 25-0126-DIS and shall be addressed to the attention of John T. Coyne, Chief Enforcement Counsel, Department of Consumer Credit, 629 NE 28th Street, Oklahoma City, Oklahoma 73105.

(5) A file stamped copy of this Consent Order will be returned to Respondent upon signature of the Administrator of the Department of Consumer Credit or the Deputy Administrator of the Department Consumer Credit.

(6) If Respondent fails to comply with the terms of this Consent Order, the Administrator of the Department of Consumer Credit is authorized to file an application to enforce this

Consent Order in the District Court of Oklahoma County, Oklahoma
in accordance with the provisions of 59 O.S. § 2095.17(c).


