CONSENT ORDER

Petitioner, State of Oklahoma *ex rel.* Department of Consumer Credit ("Petitioner") and Respondent, US Roadshow Inc., ("Respondent") voluntarily enter into this Consent Order as an informal disposition of this individual proceeding to avoid litigation. Respondent agrees to waive its right to a hearing under the Oklahoma Administrative Procedures Act and both parties agree as follows:

(1) Petitioner restates and incorporates by reference the allegations made by the Petitioner in the Notice of Hearing filed in this matter.

i. Respondent has no business filing with the Oklahoma Secretary of State.

ii. Respondent was transacting business in a conference center located at 3340 S. 79th East Ave., Tulsa, OK 74145.

iii. On April 14, 2026, Jimmie Ray and Michael Thompson, Consumer Credit Investigators, arrived at Respondent's location at 3340 S. 79th East Ave., Tulsa, OK 74145, and observed a photo of a standee which was located outside a conference room that stated "Exclusive Buying Event". It advertised buying gold, silver, and jewelry. The standee also listed Respondent's name and phone number. The Investigators spoke with James Kay. Mr. Kay advised Respondent buys jewelry and precious metals from consumers. James advised he purchases items from consumers and pays via check. The Investigators requested and scanned three

bills of sale. Bill of sale #10365 showed a purchase of 10k Gold Jewelry for \$900. Bill of sale #10367 showed a purchase of 10k & 14K Gold, and a Rolex for \$6,245. Bill of sale #10369 showed a purchase of 11 Sterling Handles for \$88. Mr. Kay advised Respondent's corporate address is 12574 Flagler Center Blvd, Ste 101, Jacksonville, FL 32258, and the owner's name is Mehmet Gundogdu. The Investigators called Mr. Gundogdu and asked if Respondent was licensed to buy precious metals and gems. Mehmet advised no but would apply for a license immediately.

iv. As of the date of the Notice and Order of Hearing, Respondent was not licensed as a precious metal and gem dealer.

v. On June 15, 2026, Petitioner received a Precious Metal and Gem Dealer license application from Respondent.

(2) Respondent does not admit to the allegations made by the Petitioner in the Notice and Order of Hearing filed in this matter, and incorporated by reference in this Consent Order, except that Respondent admits the facts necessary to establish the Department's jurisdiction over Respondent and the subject matter of this action.

(3) Respondent agrees to pay a civil penalty of \$2,500.00, payable to the Oklahoma Department of Consumer Credit, on or before July 2, 2026.

(4) The payment shall be made payable by check or money order to the Oklahoma Department of Consumer Credit, shall indicate the payment is for Case Number 26-0070-DIS and shall be addressed to the attention of John T. Coyne, Chief Enforcement Counsel, Department of Consumer Credit, 629 NE 28th Street, Oklahoma City, Oklahoma 73105.

(5) A file stamped copy of this Consent Order will be returned to Respondent upon signature of the Administrator of the Department of Consumer Credit or the Deputy Administrator of the Department Consumer Credit.

(6) If Respondent fails to comply with the terms of this Consent Order, the Administrator of the Department of Consumer Credit is authorized to file an application to enforce this Consent Order in the District Court of Oklahoma County, Oklahoma in accordance with the provisions of 59 O.S. § 1528(H).

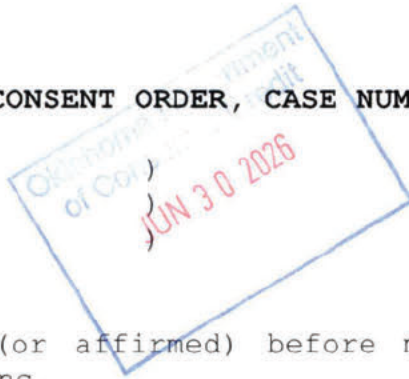
