APPENDIX V. CHANGES IN DOLLAR AMOUNTS - July 1, 2026**

Various dollar amounts set forth in the Uniform Consumer Credit Code shall change using figures from Consumer Price Index Indicators, Consumer Price Index for Urban Wage Earners and Clerical Workers (CPI-W), provided that the percentage of change, calculated according to the nearest whole percentage point, between the Index at the end of 2025 and the Reference Base Index meets the threshold requirements specified in the Uniform Consumer Credit Code.
