# Oklahoma Commission for Rehabilitation Services Department of Rehabilitation Services In-Person and Videoconferencing Commission Minutes September 11, 2023

## CALL TO ORDER AND ROLL CALL

The meeting was called to order at 10:30 a.m. by Commission Acting Chair Hilliard. Two Commissioners were in attendance; therefore, there was a quorum.

## **PRESENT**

Wes Hilliard, Commission Acting Chair Theresa Flannery, Commission Member

## STATEMENT OF COMPLIANCE

Carol Brown, Commission Assistant confirmed the Commission for Rehabilitation Services follows the Open Meetings Act.

### **COMMISSION MEETING MINUTES**

Commission Acting Chair Hilliard asked for a motion and vote to approve the August 10, 2023, Commission for Rehabilitation Services Meeting Minutes.

Motion was made by Commissioner Flannery and seconded by Acting Chair Hilliard to approve the August 10, 2023, minutes. Both Commissioners voted in the affirmative. Motion passed.

# **EXECUTIVE DIRECTOR**

Commission Acting Chair Hilliard recognized Melinda Fruendt, Executive Director.

Mrs. Fruendt had several Certificates of Appreciation to present. The first certificates went to **Tonya Garman, Brenda Knutson, Craig Glasscock, Barbara Reed**, and **Stephanie Roe** for their continued work as Hope Navigators.

The second certificates went to **Melanie Ullfers, Collin Jenks, Brian King and Marka Simms** of the Oklahoma Library for the Blind and Physically Handicapped (OLBPH). They worked tirelessly on the "Beyond Recall" project. This project was a process where the OLBPH would send books back to the National Library Service for them to reuse or make new books. This group sent our 150,000 total individual books, 3,401 boxes, and 155 large rolling USPS mail bins full. By doing this, it will save the state money by creating space for a DRS office. Now the OLBPH is totally digital.

The third certificates went to **Kim Lohr, Brian Montgomery, and Laura Rees** for developing an innovative tool which can be used to provide dual contact information in one package. They designed a card which shows both the counselor and Page 2

rehabilitation technician's contact information. This enables the client to maintain one card for their use in contacting his counselor. Since this has been designed the response has been very positive and dual-card orders are now being requested and processed. Their creativity has made things easier on clients, employers, and vendors in work with DRS.

The fourth certificates went to **Tom Patt, April Story, Caryn Mitchell, and Tommy Pham**. Effective July 13, 2023, OMES/HCM ceased doing applicant reviews for all current and future vacancies in Workday. This group developed and implemented a plan where they began reviewing applicants for vacancies and determining which vacancies were the highest priority and needed review immediately. Their process was demanding. This group spent long hours working on it and yet maintained their current workload. They averted what could have been a crisis in our recruitment process as we seek to fill critical positions throughout the agency.

Mrs. Fruendt continued with her Executive Director's report. She had a remembrance for Tracy Brigham's mother, who passed away last Thursday. Mrs. Fruendt also reviewed her meetings with staff, and state agencies and commissions. She gave updates on Federal reporting, AWARE, Case Reviews, and Program Standards, Statistical Research.

Mrs. Fruendt wanted to make the Commissioners aware of an Emergency Declaration DRS made to OMES Capitol Assets Management. On August 11, 2023, she notified the Capitol Assets Management, through an Emergency Declaration, work at the Oklahoma School for the Deaf dormitories was still under construction. The work was to be completed by December 22, 2022. As of August 2023, it has not been completed. OSD is housing students in other facilities and declared an Emergency to get a new contractor. As of date, a new contractor has not been secured.

# PRIORITY GROUP, PORTAL REFERRALS UPDATE AND SBVI REPORT

Commission Acting Chair Hilliard recognized Theresa McDermott, SBVI Field Service Coordinator. Mrs. McDermott gave the Priority Group, Portal Referrals update, and SBVI report for Tracy Brigham.

Update on Priority Groups: Priority Group I is still open. September 6<sup>th</sup> two hundred ten (210) were released. As of today, Group II has one thousand fifty-six (1,056) and Group III has two hundred three (203), with a total of one thousand two hundred fifty-nine (1,259).

Update on portal referrals: As of September 5, there has been a total of four hundred twenty (420) on-line referrals of which one hundred twenty-one (121) are either active or pending action. In addition, eight-two (82) applications have been taken. Cases with application, the median days between the referral being completed online, and the date the referral is closed, when the application is entered, is twenty-nine (29) days.

SBVI report: Mrs. McDermott gave updates on Field Services, including **new staff**, **Rehabilitation Teacher Jenifer Harris in Sapulpa, VR Specialist Latifa Wright in** 

Oklahoma City, Rehabilitation Teacher Jennifer Ratliff in Tulsa, and Deaf Blind Specialist Kelley Gutierrez is now a Certified Rehabilitation Counselor; OLBPH; AIM Center; BEP; Recruitment and Outreach Coordinator; and Division Administrator activities.

# **FINANCIAL**

Commission Acting Chair Hilliard recognized Kevin Statham, Chief Financial Officer to present the Financial Status report for FY 23 and FY 24 as of July 31, 2023.

Mr. Statham also presented the FY 2024 Supplemental Budget Request and the FY 2025 Budget Request for review and approval.

Motion was made by Commissioner Flannery and seconded by Acting Chair Hilliard to approve the FY 2024 Supplemental Budget and the FY 2025 Budget Request. Both Commissioners voted in the affirmative. Motion passed.

## **HUMAN RESOURCES**

Commission Acting Chair Hilliard recognized Tom Patt. Mr. Patt reported on the Personnel activity as of August 31, 2023.

Mrs. Briscoe gave updates on the Pre-ETS (Pre-employment Transition Services) services, STEM (Science Technology Engineering Mathematics), VIBE (Visually Impaired Blindness Empowerment), and BEST (Building Employment Skills for Today).

Commission Acting Chair Hilliard recognized Shelly Gladden from ABLE TECH to give the ABLE TECH report for Allyson Robinson. The ABLE TECH report provided updates on the Alternative Financing Program Report, Portfolio Performance, Loan Information, Creating an Accessible Workforce System for All Contracts, and AT, AEM and ICT Accessibility for Pre-ETS contracts.

## **AWARE**

Progress is being made on the API portal project, which once completed, will enable us to extract data collected by contracted Pre-ETS providers directly into AWARE instead of relying on manual entry.

We have continued to collaborate with DRS Purchasing to implement a new method for purchasing client services using P-Cards.

Working with Alliance Enterprises to determine if auto-budget selection is a feature that would be beneficial to implement in AWARE.

### **Case Review**

# Their story

Edmond North senior Ethan Smith participated in the DRS' Transition's BEST Step summer job training and employment program in summer 2023. Ethan, who has autism, attention-deficit/hyperactivity disorder, hearing loss and intellectual disabilities, enjoyed working as a sacker at Uptown Grocery in Edmond. After the summer program ended, Store Manager Shane Kennedy wanted to hire Ethan to work on a permanent, part-time basis, but had to wait until he had a vacancy for budget reasons.

During the month that Ethan was off work, Shane had 20 phone calls from customers who asked, "Where's that kid who's always smiling?" They missed Ethan and so did Shane because Ethan is a great worker with a positive attitude. Today, Ethan is back at work at Uptown Grocery and happy to be there. Uptown Grocery employs other workers with disabilities, including Caleb who has worked there 17 years.

- Oklahoma Deaf Education Training Institute will kick off on September 30 with 7 students. These students are teachers working at schools around Oklahoma. The goal is to help them to gain a better understanding on Deaf education and language so they can provide better services for their students in their schools.
- Parent/Teacher Conferences will be held on Tuesday, October 3 and spaghetti dinner will be provided by the cafeteria and is sponsored by OSD Foundation.
- We currently have 15 vacant positions and 2 in the HR process. 4 new employees will begin working at OSD on October 2.
