Beyond Hope Academy - Tonya Garman, Executive Coordinator

Beyond Hope Academy had its first meeting on February 7, 2024 and is expected to wrap up on May 29, 2024. This is a 4-month immersion into *The Science and the Power of Hope*, with the purpose of finding innovative pathways to utilize Hope theory at DRS.

Interested employees completed an application process which included an explanation of why they were interested in attending. Our first Cohort has 7 participants and is meeting for multiple sessions. The cohort has already visited with DHS Hope Ambassador, Tammy Williams, to hear firsthand how their agency infused

the Hope mindset into their everyday work. Another session brought us a 'leadership studio interview' with Dr. Angela Pharris, from OU's Hope Research Center. Future meetings include a tour of the Workforce Community Hope Center and further development of the group's project.

Participants have created a project goal and are developing pathways by outlining how Hope can be integrated into DRS culture. In May, the group will pitch their ideas, in Shark Tank® fashion, to members of the DRS E-team.

In March, the Beyond Hope Academy was spotlighted as an example of 'Hope in Action' on the Oklahoma Hope Navigator Team's channel. We are excited to be acknowledged for the continuing work at DRS.

The next 6-hour individual *Science and Power of Hope* training is scheduled for May 21, 2024. In addition, unit specific trainings are available with dates being scheduled throughout 2024. For more information contact Hope@okdrs.gov or use the link below for enrollment.

Administrative Rules Cycle - VR/SBVI - Tonya Garman, Executive Coordinator

The Administrative Rules Process is active again for the 2025 Rules Cycle. The VR and SBVI Division Administrators and Field Coordinators are developing a list of the policy that will be discussed this year. Field staff were invited to submit any issues that they have identified as needing revision, as well as additional suggestions from our federal partners at RSA. Assigned work groups will be amending the current policy through the summer and final draft versions of the changes will be submitted to Tina Calloway before October 1.

During November, we will be working with ORC to host an "overview" where this year's selections will be clarified and explained as needed to our partners and stakeholders.

Any VR/SBVI Administrative Rules revision suggestions can be referred to Tonya Garman for consideration.

SILC and IL Network – Tonya Garman, Executive Coordinator

The Oklahoma State Plan for Independent Living (SPIL) is currently in development to be submitted to the Administration for Community Living by June 30, 2024. The 2025-2027 SPIL is a 3-year blueprint for the independent living network in the state. It is developed jointly by the Oklahoma Statewide Independent Living Council, the Centers for Independent Living and the Designated State Entity, which DRS serves as.

Process Improvement (PI) – Lyuda Polyun AWARE

The project for transitioning management reports from Tableau to Power BI, is underway.

The Missouri Pre-ETS portal project advances into the testing phase in early April, while the AWARE team is manually entering Pre-ETS data for the quarter beginning January 1 for reporting on the RSA-911.

We are collaborating with the VRTAC-QM team to tailor AWARE to enhance Period of Performance and Pre-ETS reporting, aligning with the agency's Corrective Action Plan.

An upgrade for AWARE to its latest version is scheduled for Thursday, March 28.

Case Review

The QA team for the month of March is conducting an Open case audit. QA staff continue to have bi-weekly meetings to discuss issues that arise.

The QA team continues to research and develop a series of pre-ETS questions to be audited in the future.

The QA team is working with the Change Team to isolate areas for improvement based on QA reports.

Program Standards, Statistical Research, Data Dashboards

The research staff drafted a counselor survey for the Statewide Needs Assessment and sent it to agency leadership for feedback and approval.

The staff are working on transition BI reports and updating the source information for previously published BI reports with the new server name, and the Statistical Research Specialist is continuing his SQL training for BI.

Provided requested ACS data on individuals with disabilities in Oklahoma to the State Senate Communications office.

The staff remotely attended the 2024 Annual Disability Statistics Conference.

Commission Minutes February 14, 2024

Oklahoma Commission for Rehabilitation Services Department of Rehabilitation Services (DRS) In-Person and Videoconferencing Regular Commission Meeting Minutes February 14, 2024

CALL TO ORDER AND ROLL CALL

The meeting was called to order at 10:38 a.m. by Commissioner Hilliard with a quorum present.

PRESENT

Wes Hilliard, Commission Acting Chair Theresa Flannery, Commission Member Dr. Janet Barresi, Commission Member

STATEMENT OF COMPLIANCE

Commission Assistant Kathleen Arrieta confirmed the Commission for Rehabilitation Services follows the Open Meetings Act.

PRESENTATION OF LONGEVITY CERTIFICATES

Commissioner Hilliard presented a longevity award to Marqueta Culver, who has worked 30 years at the Oklahoma School for the Blind.

EXECUTIVE DIRECTOR'S REPORT

Director Fruendt introduced Secretary Dr. Deborah Shropshire, the Director of Dept of Human Services. She thanked Secretary Shropshire for her constant and continued support of DRS.

Report highlights:

- The Christmas programs at the Oklahoma School for the Deaf and the Oklahoma School for the Blind were both outstanding, and Director Fruendt encouraged others to attend the plays next year.
- Attended DRS's Senate Pre-Budget Hearings along with Jennifer Hardin, Kevin Statham, Senator Garvin and Representative Lawson.
- Met with the Rehabilitation Services Administration (RSA) regarding Vocational Rehabilitation (VR) and Services for the Blind and Visually Impaired (SBVI) programs. Over the summer, DRS had a monitoring completed, focusing mainly on financials, and recently received the draft Monitoring Report. DRS has been in conversations with the RSA and DRS, and some of the changes are reflected in the Administrative Rules process under Employment Support Services. DRS is in the process of responding to the draft Monitoring Report.
- Attended the Legislative Office of Fiscal Transparency (LOFT) meeting, along with Jennifer Hardin and Stephanie Roe, at the State Capitol to hear the reports on the workforce and budget outlook.

- The AWARE (Accessible Web-Based Activity Reporting Environment) Team collaborated with the Financial Services Division staff to furnish data for endof-quarter and end-of-year financials and is also testing a new version of AWARE.
- The Quality Assurance Review Specialists attended a webinar about including Pre-ETS in the quality assurance case file review process, and how to utilize the results to help identify program performance and Pre-ETS trends for strategic planning. The team continues to work with field staff on case audits and closed cases.
- The Program Standard Statistical Research Group is training in Power Bi, the new platform which DRS is moving to for data.

After Director Fruendt completed her report, Commissioner Flannery asked if the Pre-ETS portal and Transition Services might improve the online portal for adults for self-referral. Director Fruendt answered that those are two different, distinct portals, and also noted that the Pre-ETS portal and Transition Services portals were delayed over the summer due to staff changes at Oklahoma University, who contracted with University of Missouri to develop the portal. DRS is in conversations with the University of Missouri team and the portal is moving forward. Commissioner Flannery asked that a definition of the portals be given at the next meeting.

SUCCESS STORY

Sandra Evans, Vocational Rehabilitation Specialist and Will Lambley

Ms. Sandra Evans introduced Mr. Lambly, who spoke about becoming blind in high school due to Leber Hereditary Optic Neuropathy. He then engaged with DRS Transition Services, where he learned to live independently and use assistive technology so that he could go to college. He's now set to graduate in May 2025, and has a podcast "Rise Above."

LEGISLATIVE REPORT

Jennifer Hardin, Legislative Liaison

- As of 2/14/24 there are 4,778 bills, with 2245 bills rolled over from the '23 session.
- SB 154, a carry-over bill from the '23 session, provides an exception for the Braille reading and ASL students from the Reading Sufficiency Act (RSA) because the current RSA testing methods don't address an infrastructure that would ensure equity practices for hearing and visually impaired.
- SB 1330 creates the Oklahoma Opportunity Scholarship Act which provides financial assistance to students with intellectual disabilities (these students are currently not included in the existing scholarship program language) pursuing studies through a Comprehensive Transition and Postsecondary (CTP) program. This is expected to pass unanimously.

CHIEF FINANCIAL OFFICER'S REPORT

Kevin Statham, CFO

Financial Status Reports for FY 2023 and FY 2024.

- Financial Status Report FY 23 As of December 31, 2023 the agency had spent \$128M of the \$168M budget, with remaining encumbrances of \$6.8M.
- Financial Status Report FY 24 As of December 31, 2023 the agency had spent \$64.2M of the \$184.8M budget, with remaining encumbrances of \$102.5M.

VOCATIONAL REHABILITATION (VR) REPORT

Mark Kinnison, Division Administrator and Yasmin Avila Guillen, Business Services Coordinator

VR Report highlights:

- Federal Performance year totals for 2023 were final on September 30, 2023. The totals for VR/SBVI are 4,262 applications, 2,212 plans for employment and 1,071 employment outcomes.
- VR/SBVI staff attended the Council of State Administrators of Vocational Rehabilitation (CSAVR) conference in October. The conference presented 2022 performance measures, and the VR/SBVI divisions compared favorably to the national averages. DRS is 2nd in the nation regarding the measurable skill gain rates, with a 75.1% credential attainment rate.
- The VR/SBVI programs saw 283 individuals earn wages high enough to go off Social Security Income and Social Security Disability Income. DRS is one of the national leaders in this area.
- Priority Group Update: Priority group 1 is open. Priority groups 2 and 3 are closed. On 2/7/24, 202 individuals were released from Priority Group II. As of 2/14/24, the agency has 940 individuals on the Priority Group II waitlist, and 227 on the Priority Group III waitlist, which leaves 1167 individuals on the waitlist.
- Portal Update: So far, 192 applications have been taken on 750 total individuals who self-referred. Three hundred and seventy-four (374) applications have been closed without a case being taken. One hundred and eighty-four (184) applications are still active or pending.

Commissioner Flannery asked if DRS had tracked the measurable skills gain rate data long enough to see if the data shows higher wages and full-time employment. Mr. Kinnison answered that there is 5 years of data and the wages have increased every year. Employment has also increased, and Mr. Kinnison will provide more data after the CSAVR conference in April. Commissioner Barresi asked for a definition of the Priority Groups and the Portals.

2023 Business Services Program (BSP) Report highlights:

- Partnered with Mercy Hospital to host an event focusing on occupations in healthcare.
- Initiated partnerships to boost job opportunities with Langston University, Randstand International, CVS, Ditch Witch, and Mercy Hospitals.

 The BSP team attended several trainings and events including Oklahoma Human Resources State Council (OKHR); OKC Chamber of Commerce, Claremore Chamber of Commerce, Green County Business Advisory Council (BAC), and Employers in Action, a coalition of HR and employment professionals led by The State Chamber.

HUMAN RESOURCES REPORT

Tom Patt, HR Director

- Personnel Activity report as of January 31, 2024: 22 vacant positions were filled; 57 positions are open.
- Current Full Time Equivalent (FTE) status There are currently 949 FTE positions.

STATEWIDE INDEPENDENT LIVING COUNCIL REPORT

Kevin Nelson, Attorney, SILC

SILC is seeking legislation through the Attorney General's office to resolve ongoing issues with the Open Meetings Act. Currently there are no provisions for accommodations for board members with disabilities to attend meetings virtually (as an accommodation), which makes achieving quorum difficult.

WORKFORCE INNOVATION AND OPPORTUNITY ACT (WIOA) STATE PLAN, VOCATION REHABILITATION SERVICES PORTION REPORT

Stephanie Roe, Project Coordinator

- DRS is in the process of updating the State plan, currently in draft status, for 2024 – 2027, which is a combined state plan for the Oklahoma Employment Security Commission as well as the Oklahoma Department of Career and Technology Education (Career Tech).
- The draft State Plan is currently in the thirty-day public comment period, which will close on February 16th. So far, there are no public comments for the plan. The plan is due to the Department of Education on March 4th.

COMMUNICATIONS PRESENTATION

Jody Harlan, Director of Communications

A video titled "In Our Own Words" was shown which featured Vocational Rehabilitation (VR) and Services for the Blind and Visually Impaired (SBVI) clients speaking about the services they have received. This PSA will be shown on several television stations.

ACTION ITEMS

REVIEW OF THE MINUTES FROM THE DECEMBER 11, 2023 COMMISSION MEETING

Wes Hilliard, Acting Chair

A motion was made by Commissioner Flannery and seconded by Commissioner Barresi to approve the minutes from the December 11, 2023 Regular Commission meeting as submitted. The vote was unanimous, and the motion carried.

ADOPTION OF PROPOSED ADMINISTRATIVE RULE REVISIONS

Tina Calloway, Rulemaking Liaison

Highlights of the rule revisions include:

- <u>612:10-7-1 (b)17</u> Correction. The word "support" is inserted between term and from, with the final phrase reading: "...who require short term support from an employment counselor..."
- 612:10-13-20 (b) DRS is withdrawing these corrections and will leave policy section (b) as it currently reads. This section will be reviewed and reworked later considering comments that were received during the open comment period. Tonya Garman said that public commenters noted that doubling the continuing education units needed for interpreters from 10 hours to 20 hours would be a hardship for interpreters both because of a perceived lack of training and the increased cost. DRS is also looking at the possibility of providing some free training opportunities for interpreters.
- 612:1-3-10 (2) Commissioner Barresi asked for an explanation of the Final Signature Authority rule revision. It was explained that the cost of goods and services have risen exponentially since the pandemic, therefore the rule has been revised to give the Chief of Staff, Chief Operations Officer and the Chief Financial Officer signing authority for contracts up to \$250K (revised from \$100K), in the case that Director Fruendt is unavailable to sign contracts. Additionally, each approval has several steps before being finally signed, including a structure for fiscal accountability for the auditor.
- <u>612:1-3-10 (3)</u> Division Administrators also have a revised contract signing authority due to increased costs. They can now sign contracts up to \$200K (revised from \$100K).

A motion was made by Commissioner Flannery and seconded by Commissioner Hilliard to adopt the Department of Rehabilitation Services (DRS) Administrative Rules with two modifications. Commissioners Flannery and Hillard voted in the affirmative and Commissioner Barresi abstained. The motion carried.

ACCEPTANCE OF DONATIONS TO THE OKLAHOMA SCHOOL FOR THE BLIND Rita Echelle, Superintendent

The donations for December 2023 totaled \$18,141,50, and the donations for January 2024 totaled \$5467.43.
