HCPCS PROCEDURE CODE Q4050 (CAST SUPPLIES)

- 1. IS THIS A RATE CHANGE OR A METHOD CHANGE? Rate Change

3. PRESENTATION OF ISSUE - WHY IS THIS CHANGE BEING MADE?

The Oklahoma Health Care Authority currently manually prices procedure code Q4050 during the prior authorization process. The procedure code has been priced at \$35 for several years based on invoices the previous DME director received.

4. CURRENT METHODOLOGY AND/OR RATE STRUCTURE.

This code is currently manually priced at \$35 on a prior authorization.

5. NEW METHODOLOGY OR RATE STRUCTURE.

The Oklahoma Health Care Authority requests HCPCS Procedure Code Q4050 to \$35.00 per item. This price was determined based upon invoices submitted to the previous DME director. This change will lower the amount of time the prior authorization staff spends on these authorizations.

6. BUDGET ESTIMATE.

This item is budget neutral.

7. AGENCY ESTIMATED IMPACT ON ACCESS TO CARE.

This will not have a negative impact on access to care.

8. RATE OR METHOD CHANGE IN THE FORM OF A MOTION.

The Oklahoma Health Care Authority requests the State Plan Amendment Rate Committee approve HCPCS Procedure Code Q4050 to \$35.00 and remove the Prior Authorization requirement.

HCPCS PROCEDURE CODE A4335 (INCONTINENCE SUPPLY)

3. PRESENTATION OF ISSUE - WHY IS THIS CHANGE BEING MADE?

The Oklahoma Health Care Authority currently must manually price this procedure code. Since this item is highly utilized but has very low pricing the agency was spending more money in administrative costs to process the claims than the claims cost.

4. CURRENT METHODOLOGY AND/OR RATE STRUCTURE.

This code is manually priced from invoices, paying the lesser of MSRP minus 20% or cost plus 20%.

5. NEW METHODOLOGY OR RATE STRUCTURE.

After reviewing invoices for the time, the Oklahoma Health Care Authority requests HCPCS Procedure Code A4335 to \$.06 per item. This is the same price that appears on most invoices received from providers.

6. BUDGET ESTIMATE.

This item is budget neutral, but will save considerable staff time in pricing these claims.

7. AGENCY ESTIMATED IMPACT ON ACCESS TO CARE.

This will not have a negative impact on access to care.

The Oklahoma Health Care Authority requests the State Plan Amendment Rate Committee approve HCPCS Procedure Code A4335 to \$.06 per item
