A. Brief description of the purpose of the rule:

The proposed additions will implement secure mental health transportation as a covered benefit to SoonerCare members. The policy additions will outline what secure mental health transportation is and the specific services/requirements including but not limited to, eligible provider (driver/contractor) requirements, member program eligibility and the covered services, as well as the radius that will be taken into consideration when transporting members. Finally, additions will state that reimbursement for secure mental health transportation is outlined in the Oklahoma Medicaid State Plan.

B. A description of the classes of persons who most likely will be affected by the proposed rule, including classes that will bear the cost of the proposed rule, and any information on cost impacts received by the agency from any private or public entities:

SoonerCare members who are in need of secure mental health transportation will be positively affected by the proposed rule changes.

The proposed rule changes to allow secure mental health transportation will benefit SoonerCare members who utilize these services, by allowing access to these specific providers.

RULE TEXT:

TITLE 317. OKLAHOMA HEALTH CARE AUTHORITY CHAPTER 30. MEDICAL PROVIDERS-FEE FOR SERVICE

SUBCHAPTER 5. INDIVIDUAL PROVIDERS AND SPECIALTIES

PART 115. SECURE MENTAL HEALTH TRANSPORTATION

317:30-5-1225. Definitions

The following words and terms, when used in this Part shall have the following meaning, unless context clearly indicates otherwise:

- "Behavioral health (BH) services" means a wide range of diagnostic, therapeutic, and rehabilitative services used in the treatment of mental illness, substance abuse, and co-occurring disorders.
- "Member/eligible member" means any person eligible for SoonerCare and individuals considered to be Medicare/SoonerCare dual eligible.
- "Nearest treatment facility" means a medical facility that is generally equipped and legally permitted to provide the needed care for the illness or injury involved that is the closest in geographical proximity to the members' pickup location.
 - "OAC" means Oklahoma Administrative Code.
- "ODMHSAS" means the Oklahoma Department of Mental Health and Substance Abuse Services.
 - "O.S." means Oklahoma Statutes.

317:30-5-1226. Program overview

- (a) Per Title 43A O.S. Section (§) 1-110, the ODMHSAS shall contract with qualified transportation service providers (QTSP) to transport SoonerCare members to and from designated sites/facilities for the purpose of examination, emergency detention, protective custody, and inpatient services.
- (b) Transportation services shall be provided twenty-four (24) hours, seven (7) days a week by driving those SoonerCare members, who are in crisis, to the level of care needed for treatment, including occasional facility-to-facility transportation for step down care.

- (c) SoonerCare members being transported shall be afforded all rights and privileges guaranteed by the laws and regulations of the State of Oklahoma. SoonerCare members have the right to be transported in a way that protects the dignity and safety of the individuals.
- (d) Only commission peace officers, or other persons as allowed by federal and state law, may use physical restraints in the transportation of members as provided by Title 43A O.S. § 1-110.

317:30-5-1227. Eligible providers

- (a) **Driver requirements.** Drivers must meet, but are not limited to, the following requirements:
 - (1) Be twenty-one (21) years of age or older;
 - (2) Have a valid driver's license issued by the State of Oklahoma;
 - (3) Undergo a criminal background check;
 - (4) Able to ensure that SoonerCare members who are transported are protected by harm and injuries;
 - (5) Be able to provide emergency care or have an established plan to access emergency care;
 - (6) Be trained in effective communication skills with persons with mental illness;
 - (7) Be able to recognize and plan for problematic behaviors in a therapeutic and safe manner;
 - (8) Be familiar with the statutes and standards related to transporting members;
 - (9) Transport patients in a vehicle which:
 - (A) Is well maintained and in good mechanical condition;
 - (B) Have the following operational equipment:
 - (i) Air conditioner;
 - (ii) Heater; and
 - (iii) Chemical-type fire extinguisher, of at least a one-quart capacity, that is located in the same compartment of the vehicle as the driver.

- (b) Contractor requirements. Contractors must meet, but are not limited to, the following requirements:
 - (1) Ensure that all drivers/vehicles meet the criteria listed in (a) of this section;
 - (2) Ensure that all drivers, who are not certified as a peace officer in Oklahoma, complete a sixteen (16) hour Therapeutic Options Course that is certified by the Oklahoma Department of Mental Health and Substance Abuse Services;
 - (3) Ensure that all vehicles have a safety partition between the driver's area and passenger's area;
 - (4) Equip the car with safety locks to prevent a consumer from exiting a car that is in motion;
 - (5) Equip the car/driver with a two-way radio or cellular telephone that is operational during the entire period of transport;
 - (6) Provide drivers, who are transporting members in wheelchairs, vehicles that are equipped with the following:
 - (A) An electrical or hydraulically operated lift mechanism or a ramp with a non-skid surface;
 - (B) A means of securing a wheelchair to the inside of the vehicle to prevent any lateral, forward, backward, or vertical motion of the wheelchair within the vehicle;
 - (C) A rear-view mirror that enables the driver to view any passenger in a wheelchair; and
 - (D) A door at the rear of the vehicle for an emergency exit.
 - (7) Provide a monthly progress report to ODMHSAS, which includes but is not limited to:
 - (A) Number of transports conducted;
 - (B) Outcome of each transport; and

- (C) Any incidences that occurred.

- (c) Non-discrimination. All secure mental health transportation drivers and contractors may not otherwise discriminate against members on the basis of race, color, national origin, sex, sexual orientation, gender identity, health status, need for medical services, or disability and may not use any policy or practice that has the effect of discriminating on the basis of race, color or national origin, sex, sexual orientation, gender identity, or disability.

317:30-5-1228. Program eligibility and covered services

(a) Program eligibility.

- (1) Members must be eligible for SoonerCare (Medicaid).
- (2) A member must be experiencing a behavioral health crisis as evidenced by extreme emotional distress that includes by is not limited to an acute episode of mental illness and/or suicidal thoughts and/or behavior that may occur with substance use and other disorders.

(b) Covered services.

- (1) Secure behavioral health transportation may be provided for the following transportation:
 - (A) Facility-to-facility transport between facilities including but not limited to hospital, public or private mental health facilities and medical facilities.
 - (B) Transport to and from a facility arranged by individuals authorized by ODMHSAS.
 - (C) Transport of an individual seeking voluntary admission to a public or private mental health facility.
- (2) Members must be transported to the nearest, appropriate facility.
- (3) Long distance or out-of-state transportation are allowable when medically necessary and must be prior authorized.
- (c) Radius. The ODMHSAS will provide secure mental health transportation, using unmarked vehicles with specially trained drivers, to the nearest treatment facility when greater than thirty (30) miles. If the nearest treatment facility is within thirty (30) miles of the law enforcement's operational headquarters, then transportation will be the responsibility of law enforcement.
- (d) Non-allowable services. Family members or other unaccredited agents are not allowed to travel in the secure vehicle with the recipient.

317:30-5-1229. Authorization and reimbursement

- (a) Secure mental health transportation does not require a prior authorization.
- (b) Secure mental health transportation is reimbursed per the methodology described in the Oklahoma Medicaid State Plan.
