#### **PUBLIC NOTICE**

Pursuant to 42 CFR § 447.205, the Oklahoma Health Care Authority (OHCA) is required to give public notice of any significant proposed change in methods and standards for setting payment rates for services in the SoonerCare program. The following method change will necessitate an amendment to the Oklahoma Medicaid State Plan. Additionally, due to the proposed rate increases to long-term care facilities, the Miller Trust eligibility amount effective July 1, 2021, will increase from \$5,462 to \$5,725 per month. The proposed changes were presented at the Tribal Consultation meeting on May 4, 2021 at 11:00 AM via teleconference and will be heard before the State Plan Amendment Rate Committee (SPARC) hearing on June 18, 2021 at 1:00 PM and the OHCA Board meeting on June 30, 2021, at 1:00 PM.

# Nursing Facility Rate Rebasing and Rebasing, Effective date: July 1, 2021, contingent upon CMS approval.

## **Regular Nursing Facilities**

The OHCA will seek approval of a State Plan amendment to increase rates and recalculate the quality of care (QOC) fee for regular nursing facilities. This change will also adjust the base rate component to reflect the correct amount for durable medical equipment, supplies and appliances. For the rate period beginning July 1, 2021, the base rate component will be \$123.22 per patient day. The estimated budget impact for SFY2022 will be an increase in the total amount of \$37,150,369; with \$11,802,672 in state share from QOC fees paid by providers.

## Nursing Facilities Serving Patients with Acquired Immune Deficiency Syndrome (AIDS)

The OHCA is proposing revisions to increase rates and recalculate the QOC fee for nursing facilities serving residents with AIDS. This change will also adjust the rate component to reflect the correct amount for durable medical equipment, supplies and appliances. For the rate period beginning July 1, 2021, the base rate component will be \$224.05 per patient day. The estimated budget impact for SFY2022 will be an increase in the total amount of \$71,189; with \$22,617 in state share, paid by the facilities.

## Regular Intermediate Care Facilities for Individuals with Intellectual Disabilities (ICF/IID)

The OHCA is proposing revisions to increase rates and recalculate the QOC fee for regular ICF/IIDs. For the rate period beginning July 1, 2021, the rate will be \$129.79 per patient day. The estimated budget impact for SFY2022 will be an increase in the total amount of \$159,822; with \$50,775 in state share from the increased QOC fee, paid by providers.

### Acute Intermediate Care Facilities for Individuals with Intellectual Disabilities (ICF/IID)

The OHCA is proposing revisions to increase rates for Acute ICF/IIDs. For the rate period beginning July 1, 2021, the rate will be \$164.62 per patient day. The estimated budget impact for SFY2022 will be an increase in the total amount of \$128,439; with \$40,805 in state share from the increased QOC fee, paid by providers.

#### **Increase Ventilator Add-on Rate**

The OHCA is proposing revisions to increase the add-on rates to facilities serving Medicaid beneficiaries who require ventilators. For the rate period beginning July 1, 2021, the rate will be \$186.64 per patient day. There is no budget impact as this change will be funded using existing funds.
