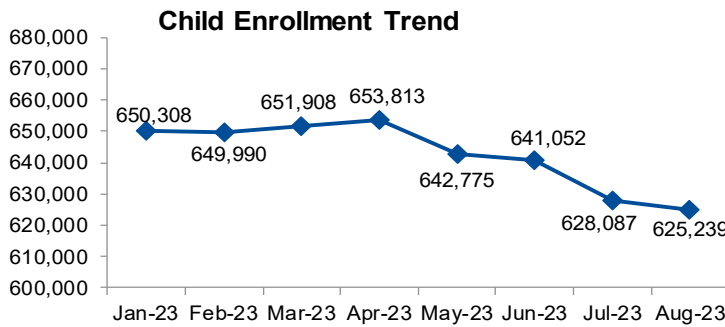
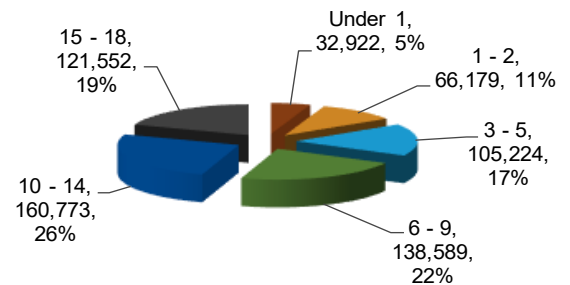

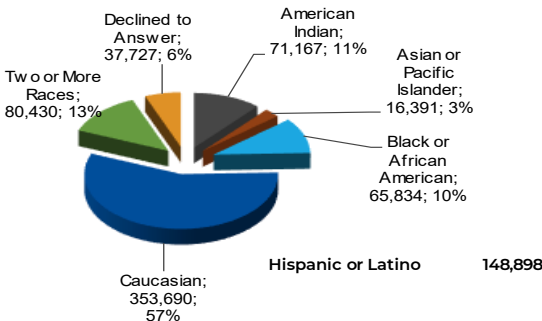
Age Breakdown of Child Enrollment
