
CHIP Breakdown of Total Enrollment





OHCA, OSDE to Enhance Schoolbased Services with Federal Grant

Oklahoma City, OK – The Oklahoma Health Care Authority (OHCA), in conjunction with the Oklahoma State Department of Education (OSDE), received a \$2.5 million, three-year grant to provide technical assistance to enhance the school-based services (SBS) infrastructure in Oklahoma. This investment will allow more students and their families to connect with local and state health care resources.

School-based services are Medicaid-compensable services provided to children and adolescents in a school setting. These health care services play an important role in the health and wellbeing of students enrolled in SoonerCare. Currently, only students with an Individualized Education Program (IEP) can receive SBS.
