



#### Age Breakdown of Total Enrollment




#### SCHIP Breakdown of Total Enrollment

State Fiscal Year is defined as the period between July 1 and June 30 of each fiscal year. BCC is the acronym for Breast and Cervical Cancer coverage and FP is Family Planning waiver clients. TEFRA is included in the OTHER category.

News Release

TEFRA (Tax Equity and Fiscal Responsibility Act) makes benefits available for children with physical or mental disabilities who would not ordinarily be eligible for Supplemental Security Income (SSI) benefits because their parents' income or resources were too high. Under TEFRA, only the child's income and resources are counted.

To be eligible for TEFRA, a child must meet income guidelines, be younger than age 19, live at home, meet the Social Security Administration's definition of disability and require an institutional level of care.

Also, it must be appropriate to provide care at home, and the cost of care can't exceed the estimated cost of treating the child in an institution.

Children who qualify for TEFRA will receive the full scope of Medicaid services, such as inpatient and outpatient treatment, prescription drugs, occupational and physical therapy and medical equipment.
