Step Therapy Tier Changes

The following changes will take effect January 1, 2018. Complete tier lists and prior authorization (PA) criteria can be found on our website at <u>www.okhca.org/pa</u>.

Alzheimer's Medications

• Namenda XR[®] [memantine extended-release (ER)] will require a reason why the member cannot use the immediate-release formulation

Asthma Medications

• Qvar[®] HFA (beclomethasone) will no longer be available; use of the new Qvar[®] Redihaler[™] formulation will require a reason for use in place of other Tier-1 inhaled corticosteroids

Antidepressant Medications

• Viibryd[®] (vilazodone): move from Tier-2 to Tier-3 (current users will be grandfathered despite move up) <u>Atypical Antipsychotic Medications</u>

• Abilify Maintena[®] (aripiprazole), Aristada[®] (aripiprazole lauroxil), Invega Sustenna[®] (paliperidone), and Invega Trinza[®] (paliperidone): move from Tier-2 to Tier-1

Diabetic Medications

- Invokana[®] (canagliflozin), Invokamet[®] (canagliflozin/metformin), Jentadueto[®] (linagliptin/metformin), and Tradjenta[®] (linagliptin): move from Tier-2 to Tier-3 (current users will be grandfathered despite move up)
- Farxiga[®] (dapagliflozin), Jardiance[®] (empagliflozin), Synardy[®] (empagliflozin/metformin), Synjardy[®] XR (empagliflozin/metformin ER), and Xigduo[®] XR (dapagliflozin/metformin ER): move from Tier-3 to Tier-2
- Bydureon[®] (exenatide ER): move from Tier-3 to Tier-2

Fibromyalgia Medications

- Lyrica[®] (pregablin): move from Tier-3 to Tier-2
- Savella[®] (milnacipran): move from Tier-2 to Tier-3 (current users will be grandfathered despite move up) Hepatitis C Medications
 - Sovaldi[®] (sofosbuvir), Viekira Pak[™] (dasabuvir/ombitasvir/paritaprevir/ritonavir), and Viekria XR[™] (dasabuvir/ombitasvir/paritaprevir/ritonavir ER) are no longer preferred (current users will be grandfathered despite no longer being preferred)

Opioid Analgesics

• Embeda[®] (morphine/naltrexone): move from Tier-3 to Tier-2

Ophthalmic Medications

- Alphagan P[®] 0.1% (brimonidine) and Combigan[®] 0.2%/0.5% (brimonidine/timolol): move from Tier-1 to Tier-2 (current users will be grandfathered despite move up)
- Ilevro[®] 0.3% (nepafenac): move from Tier-2 to Tier-1
- Tobradex[®] (tobramycin/dexamethasone suspension) (brand only): move from Tier-2 to Tier-1

Stimulant Medications

- Adzenys XR-ODT[™] (amphetamine ER-ODT): move from Tier-2 to Special PA Tier (current users will be grandfathered despite move up)
- Focalin XR[®] (dexmethylphenidate ER) (brand only) and QuilliChew ER[™] (methylphenidate ER chewable): move from Tier-2 to Tier-1
- ProCentra[®] (dextroamphetamine oral solution): move from Tier-3 to Special PA Tier (current users will be grandfathered despite move up)
