## **PUBLIC NOTICE**

Pursuant to 42 CFR § 447.205, the Oklahoma Health Care Authority (OHCA) is required to give public notice of any significant proposed change in methods and standards for setting payment rates for services in the SoonerCare program. The following method change will necessitate an amendment to the Oklahoma Medicaid State Plan. The proposed changes were presented at the Tribal Consultation meeting on July 7 at 11:00 AM via teleconference.

## OK SPA 20-0036, SUPPORT Act Medication-Assisted Treatment (MAT), Effective date: October 1, 2020, contingent upon CMS approval.

Effective October 1, 2020, the OHCA in collaboration with the Oklahoma Department of Mental Health and Substance Abuse (ODMHSAS) will seek approval of a State Plan Amendment (SPA) to establish Medication-Assisted Treatment (MAT) services in opioid treatment programs (OTPs) and within office-based opioid treatment (OBOT) settings. The SPA will set forth provider requirements, provider limitations, covered services, excluded services, and reimbursement methodologies for services within OTPs and OBOTs. Impacted providers by the change include but are not limited to physicians, physician assistants, advanced practice registered nurses, and behavioral health providers. Reimbursement for OTP services will be established based on the established fee-for-service reimbursement methodologies currently approved under the State Plan for each individual treatment component, such as medication, behavioral health interventions, and physician services.

The estimated total budget impact for the SPA proposal in state fiscal year (SFY) 2021 is \$2,803,817; with a state share of \$838,588. The estimated total budget impact for state fiscal year (SFY) 2022 is \$3,723,890 with a state share of \$1,131,789. Together, the ODMHSAS and OHCA will meet the state share responsibility.
