**AMENDMENT THREE TO THE CONTRACT BETWEEN  
OKLAHOMA HEALTH CARE AUTHORITY**

**AND**

**OKLAHOMA COMPLETE HEALTH, INC.**

The Oklahoma Health Care Authority (OHCA) and Oklahoma Complete Health, Inc. (hereinafter referred to as Contractor) mutually consent to modify the language of the Agreement associated with Purchase Order number 8079004726 as enumerated below.

**This document serves as an amendment to the previous contract amendment and further modifies the following as stated below.**

- a. Section 1.16, "Provider Payment", add a new subsection (1.16.1.15) to read as follows:

(1.16.1.15) Hospital Pass-Through Payments

*The State requires that Contracted Entities (CEs) make pass-through payments to hospitals with an average length of stay greater than thirty-five (35) days. Contracted Entities will receive funds on a quarterly basis. Upon receipt of the funds and reports, CEs must distribute the required pass-through payments to eligible hospitals within five (5) business days. Contracted Entities are responsible for ensuring that payments are made in accordance with State and federal regulations, and in alignment with the terms specified in this amendment. Contracted Entities must submit detailed quarterly reports to the State, documenting the receipt and disbursement of pass-through payments. Reports must include a summary of funds allocated to each eligible hospital and confirmation of compliance with distribution deadlines.*

- b. Section 1.3, "Payments to Contractor", add a new subsection (1.3.7) to read as follows:

(1.3.7) Capitation Adjustments for Managed Care Transition

*The transition from Fee-for-Service to managed care for Medicaid services starting April 1, 2024. OHCA Medicaid services will be covered for the first time under managed care within the SoonerSelect Medical program. The following payments have been adjusted with a 2.25% premium tax.*

*The total pass-through payment amount for eligible hospitals is \$12,318,486.00 for the period of April 1, 2024, through June 30, 2025, under the SoonerSelect Medical Program. The distribution of payments will occur in aggregate amounts as outlined in the attached table, which identifies the allocation for eligible hospitals must distribute the required pass-through payments to eligible hospitals within five (5) business days.*
