**NOTICE TO SELECT CONSULTANTS**  
**Architectural & Engineering (A&E) Services**

The Oklahoma Office of Management and Enterprise Services (OMES), Capital Assets Management (CAM), Office of Facilities Management (OFM), intends to enter into a contract with one Architectural and/or Engineering (A&E) firm for professional consulting services to write an RFQ and RFP for the State Capitol Office Complex Tunnels located at the State Capitol Complex, Oklahoma City, OK. The OMES will select 3 firms showing interest to be selected for a site visit and tour.

The chosen firm will assist OFM and Construction and Properties in developing a preliminary plan addressing the goals and criteria of the repairs along with the necessary scoping documents of the project. The AE1 will be expected to start as soon before December 31, 2022.

Funding for the State Capitol Office Complex Tunnels Repair Project is provided through HB3567 in a total amount not to exceed \$19,000,000. The scope of services will generally include recommendations, short term and long-term capital improvements, cost projection, waterproofing, improvement of capital infrastructure projects and other related services. State of Oklahoma uses DBIA therefore experience with DBIA is preferred. Design-build experience and a history of working on State of Oklahoma projects is preferred. Additional information about the project is attached.

Please include the following information:

- **Cover Letter (one page):** indicate your interest; statement your firm is legally authorized to provide the services offered.
- **Firm Profile (one page):** outline legal structure of firm; business locations; years in business; prior firm names, if any; key personnel; qualifications by position/discipline; state your firm's limit of professional liability insurance coverage.
- **References (one page):** list not more than five (5) completed relevant projects. Include project name; location; construction cost; year completed; client name, title, and phone number.
- **Certifications/Licenses/Registrations:** only those firms and individual consultants who have the appropriate Oklahoma certifications, licenses and/or registrations for services offered will be considered. Provide copies of all certifications, licenses and/or registrations required for disciplines listed.
