**5. Collections Manager Report. [Dr. Alan Atkinson, Director of Visual Arts and Capitol Collections]**

**Update and discussion on storage of Governor's bust, standardizing hanging hardware throughout the Capitol and the conscientious work done on the west doors of Betty Price Gallery.**

Dr. Atkinson reported that a total of five bust were removed from the Hall of Governors due to Capitol restoration. Four were moved to a storage warehouse where the rest of the artwork is currently located. The remaining bust were moved to another location on the premises of the

Capitol in a secure location and are expected to be moved to the storage warehouse with the rest of the art work. The bust will be returned when restoration of the Hall of Governors is completed.

A top of the line industry standard gallery hanging system will be installed in the Senate hallways, consisting of an aluminum railing that attaches to the wall from which the steel cables incased in plastic are nearly invisible used to suspend artwork. This system will save time, to where, rather than drilling into the newly refurbished plaster walls, artworks will be hung from a system that is flexible, easily removed to paint walls, replace artwork and allows for a great deal of flexibility.
