

AGENCY DIRECTOR SALARY INCREASE REPORT FY 2022

Human Capital Management Division of the Office of Management and Enterprise Services

74 O.S. § 3601.2(B)

All increases require certification of the appointing authority that said action can be implemented for the current fiscal year and subsequent fiscal year without the need for additional funding. The agency, board, commission, department or program shall report increases granted under this section to the Office of Management and Enterprise Services on an annual basis by August 1 of each year.

The Office of Management and Enterprise Services shall forward a report of such increases to the Governor, President Pro Tempore of the Senate, and Speaker of the House of Representatives no later than September 1 of each year.

The data listed below is compiled in reliance on individual agencies reporting Executive Director increases to OMES in a timely manner as required by 74 O.S. §3601.2(B). As a result, all raises granted to executive branch state agency executive directors during fiscal year 2021 may not be contained in this report.
