**ARTICLES**

**Article 1: General.**

- 1.1 The undersigned, being familiar with the local conditions affecting the cost and performance of the Work and with the Request for Proposals (RFPs) and associated Contract Documents, including Addenda, on file at the Owner’s Office (State of Oklahoma OMES CAM Construction and Properties), and in accordance with the provisions thereof, hereby proposes to affect the enclosed Design Technical Proposal, providing all management, design, construction, commissioning (if required by RFP) and related services and the provision of all material, equipment, tools and labor necessary to complete a fully functional and operational facility, for CAP project number referenced above.
- 1.2 In submitting a proposal, it is understood that the right is reserved by the State of Oklahoma to reject any and all submissions, and it is agreed that this submission may not be withdrawn for a period of \_\_\_\_\_ (\_\_\_\_\_) calendar days after the date of closing of same. Work is to start within ten (10) days after receipt of Notice to Proceed/Work Order.
- 1.3 We propose to complete this Design-Build project within \_\_\_\_\_ (\_\_\_\_\_) calendar days from the date of receipt of the Notice to Proceed/Work Order.

**Article 2: The Work of this Contract.**

- 2.1 **The Offeror certifies that:**
  - 2.1.1 They are an Equal Employment Opportunity Employer and that they do not discriminate in any of their business or employment practices.
  - 2.1.2 They, and all subcontractors and suppliers performing work on the Project, will comply with the provisions of the Oklahoma Taxpayer and Citizen Protection Act of 2007 and participate in the Status Verification System. The Status Verification System is defined in the Oklahoma Statutes, Title 25 § 1312.
  - 2.1.3 They will comply with the laws relating to public construction in the Oklahoma Statutes (Title 61) and the Oklahoma Administrative Code (Section 260, Chapter 65).
  - 2.1.4 They will comply with all State of Oklahoma Governor’s Executive Orders, including those relating to the prohibited use of any and all tobacco products on any and all properties owned, leased or contracted for use by the State of Oklahoma, including but not limited to all buildings, land and vehicles owned, leased or contracted for use by agencies or instrumentalities of the State of Oklahoma.

**Article 3: Statements.**

- 3.1 **Non-collusion statement.** For the purposes of a competitive submission for a public construction contract, the undersigned, being first duly sworn, certifies that:

  - a. To any collusion among offerors in restraint of freedom of competition by agreement to proposal at a fixed price or to refrain from proposing.
  - b. To any collusion with any state official or employee as to quantity, quality or price in the prospective contract, or as to any other terms of such prospective contract.
  - c. In any discussions between offerors and any state official concerning exchange of money or other thing of value for special consideration in the letting of a contract.
