Security Agreement

The undersigned agrees to abide by the following:

1. Data originated or stored on State computer equipment is State property. Users will access only data which are required for their job. Users will not make or permit unauthorized use of any Oracle/PeopleSoft data. They will not seek personal or financial benefit or allow others to benefit personally or financially by knowledge of any data which has come to them by virtue of their work assignment.
2. Users will enter, change, and delete data only as authorized within their job responsibilities. They will not knowingly include or cause to be included in any record or report a false, inaccurate, or misleading entry, nor will they knowingly alter or expunge from any record or report, or cause to be altered or expunged, a true and proper entry.
3. Users will not release Oracle/PeopleSoft data except as required in the performance of their job or as directed in writing by their Appointing Authority.
4. Users are responsible for protecting their access authorization and must take steps to prevent others from using their User ID. Users will construct good passwords and manage them securely, keeping their passwords secret and not sharing them with others. If a user has reason to believe that others have learned his/her password, the user will change the password and notify the Help Desk of the situation. Users will not attempt to use the logons and passwords of others.
5. If a user finds that they have access to data they believe they are not authorized to view, they will exit from that data and report the problem to OMES Security.
6. I am aware of the responsibilities associated with access to the Oracle/PeopleSoft System and agree to abide by the OSF Information Security Policies and Procedures. I understand that according to Section 840-2.11 of Title 74 of the Oklahoma Statutes the home addresses, home telephone numbers, social security numbers, and information related to personal electronic communication devices of current and former state employees shall not be open to public inspection or disclosure without written permission from the current or former state employees or without an order from a court of competent jurisdiction.

Descriptions:

Accounting Validation – Validate Charfield values and edit when necessary.

Form 001 Req Approver – The person authorized for signature approval of the Requisition in each agency. Please attach a copy of DCS/Purchasing – Form 001 that has been filed with DCS.

Agency Buyer/CPO – The person responsible for procurement within each agency.

Asset Manager – For IT Agency asset purchases.

Approver 1 – Requisitions route to immediate Supervisor of the requisition requestor.

Approver 2 – Requisition routes to this person based on Department Codes.

Approver 3 – Approver of requisitions based on Department ID and/or under a specified Agency dollar amount.

Approver 4 – Approver of requisitions based on Department ID and over a specified Agency dollar amount.

Service Chief/Supervisor II – Requisitions route to immediate Supervisor of Approver 1.

Financial Coordinator – Requisitions route to this person based on Department Codes.
