Failure to meet the minimum performance standards shall constitute a breach of this contract and may result in termination, liquidated damages and/or disqualification from bidding on any future ITBs and RFPs issued by the State of Oklahoma for a period of time not to exceed three (3) years.

Failure to meet the minimum performance standards shall result in an assessment of actual damages, provided actual damages can be calculated; otherwise, liquidated damages shall be assessed in accordance with this agreement and for the sole purpose of compensating EGID an amount of money sustained by the PBM's breach of contract failure to

meet a performance standard. EGID shall incur no damages, inc	uding but not limited to interest payments to
providers and/or members, for the PBM's failure to meet the m	inimum performance standards.
